We are planning to address municipal services, including those available in emergencies and association legal requirements. ## **Zoning and Land Use Update**



*The following report from Zoning & Land Use Committee chair Thom Higgins includes development projects that were discussed at the January monthly meeting with City Staff, of interest to Naperville area residents, and/or under consideration by Plan Commission and Council:*

*In attendance at the January meeting - Thom Higgins for the NAHC; Greg Jones and Allison Laff for the City of Naperville*

### **New Proposals:**

**Naperville Park District** has submitted an annexation petition for the addition to Nike Park. It will be in front of the Plan Commission on Feb 17th. Additionally, the Park District will commence renovations on the Centennial beach house after the Beach closes for the season (after Labor Day 2010). It is scheduled to be completed in time for the opening of the 2011 swimming season.

**Parks Edge Subdivision:** The owner of the property west of Seager Park has submitted a re-worked development proposal for 5 duplexes that is quite similar to the previous proposal known as the Woods of Old Plank Rd. It had been scheduled to be in front of Plan Commission on Jan 20<sup>th</sup>, but was delayed to Feb 4<sup>th</sup>. Our understanding is there are not any substantive changes from the previous “The Woods of Old Plank Rd” proposal that was rejected.

**La Belle Cour (Semper Fi Properties LLC), 204-226 W. Van Buren:** On Jan 20<sup>th</sup>, the Plan Commission was presented with a plan to construct 24 condo’s in a 180’ long, three story structure on approximately one acre that is 40’ tall main body with the parapet, elevator shaft, and utilities brings it up to 43.5’ minimum and a maximum of 50’ in some places. The petitioner is requesting a number of variances including a reduction in the minimum required lot area per dwelling unit from 3,500 square feet to 1,815 square feet. If the 3,500 sq. ft. standard is applied, the petitioner would be limited to 12

units. Per staff's commentary, "this requirement is intended to restrict density (meaning the intensity of use) to promote a transition between the Downtown Core and outlying residential neighborhoods".

However, under the TU zoning classification, the minimum lot area requirement operates as a limit only on the number of units, not the size of the structure. The petitioner could still build the same size structure on the lot with only 12 units, or they can build an office or commercial use (with or without a residential component), and still occupy the same footprint and height. It is noteworthy that other zoning districts have some sort of "bulk" density limitations. In the "B" (Business districts), OCI (Office Commercial and Industrial) and PUD (Planned Unit Developments), there is a FAR (Floor Area Ratio) calculation that effectively limits the overall "bulk" of a structure. Residential districts R1 and R2 impose a Lot Area Coverage restriction and a third floor prohibition for much the same reason. As there is not any kind of comparable limitation in TU districts, the developer is free to build to the setback limits and maximum heights as is being proposed here, so long as they meet the city's design guidelines. Depending on how strict the city is on making developers comply with the guidelines, this proposal might have some difficulty, as it appears to not comply with the following; A2.1 Buildings at the outer edge of an activity center should be comparable in height and mass with the surrounding neighborhood.

Another item of interest - this is supposedly the first condo building which will have rooftop deck which raises the questions about lighting, access points (such as stairways up aka "doghouses" and/or elevator shafts for each private deck). Conceptually, there will be a common rooftop deck along the back of the project and possibly 4-6 private rooftop decks atop the east and west wings of the project

The proposal was continued by the Plan Commission until Feb 2<sup>nd</sup>. Commissioners are looking for clarification on a number of issues. The proposal can be viewed at: <http://www.naperville.il.us/ccpacket/pc20100120p.pdf>

**Kensington School Route 59 and Walton Heath;** Kensington is asking for annexation and re-zoning for a second Naperville location.

### **Ongoing Proposals:**

**CVS Pharmacy:** Has indicated they will start Demolition of the Old Pizza Hut at Ogden and Naperville Rd. shortly, with construction of a new CVS Pharmacy commencing in March.

**Huntington Place, Chicago and Westmorland:** Construction will start this spring for 8 Duplex structures. Development was approved some time ago.

**Navistar, 2600 Warrenville Rd. Lisle, IL:** On Jan 26<sup>th</sup>. Navistar officials indicated they are no longer contemplating making the controversial diesel engine testing facility part of its revised proposal to move the company's headquarters to Lisle.

Attorney Shawn Collins, representing a nearby school for autistic children, said that wasn't enough. He wants a permanent ban on Navistar ever constructing the testing facility as a condition of its approval.

Navistar expects to continue its discussion with local officials in late February.

**Naperville Downtown 2030 plan:** The Downtown Advisory Commission continues to discuss the Downtown Plan update. The January 22<sup>nd</sup> meeting discussed land use, and the February meeting will discuss building height.

**Plank Road Study:** There will be a final public meeting on February 24th where the final land use recommendations will be presented to the public. The recommendations will then go to the Plan Commission for consideration. <http://www.naperville.il.us/plankroadstudy.aspx>

**Fair Housing Advisory Commission & Mayor's Advisory Commission on Disabilities:** As a result of the feedback and input received at the November joint meeting of the Fair Housing Advisory Commission (FHAC) and the Advisory Commission on Disabilities (ACD), staff has prepared the document, *Attainable Housing: Supplemental Report of Research Findings*, for the purposes of providing the ACD, FHAC and public additional information and research on housing programs available to senior citizen and disabled households.

Based on research completed, staff will prepare cost-neutral recommendations to address identified service gaps related to low to moderate income senior and disabled households. Preliminary recommendations will be presented to the Fair Housing Advisory Commission and the Mayor's Advisory Commission on Disabilities on February 23, 2009 at 6:30 pm in Meeting Rooms B and C.

## **Coming In May – NAHC Elections**

In accordance with our bylaws, the Naperville Area Homeowners Confederation will hold elections at the Confederation Annual Meeting, scheduled for Thursday, May 20, 2010 at 7:30 PM in the Community Hall of the Alfred Rubin Riverwalk Community Center, 305 W. Jackson Avenue, Naperville, Illinois. The offices to be voted on are Secretary of the Confederation (currently Kathy Benson); Treasurer (currently Dan Bulley); and two at large Director Positions (currently held by Mike Reilly and Marcia Straub). Dan Bulley is eligible to run again for his current position.



A nominating committee will be formed at the March 18<sup>th</sup> General Meeting and will prepare a slate of recommended candidates to be announced at the April meeting. Nominations will also be accepted from the floor the day of the meeting. Any person who, at the time of the election, is a member of a homeowners association which is a Confederation member in good standing may seek and hold office on the Confederation Board of Directors; except that there shall be no

more than one Confederation Officer or a total of two Confederation Board of Directors members from any one Confederation member association.

Duties of the positions to be elected are as follows:

**Secretary** - shall keep the current minutes of all Confederation Board of Directors meetings; shall present a written report of the Confederation's previous year's activities at the Annual Meeting; and shall be responsible for all correspondence related to the business of the Confederation. The Confederation Board of Directors shall approve all material correspondence relating to the business of the Confederation and the Confederation Board of Directors. The Secretary shall also keep current a list of Member associations and persons to contact, and shall maintain duplicate copies of the corporate records. The Secretary shall be responsible for all communications with Member associations or others as the President or the Board of Directors direct.

**Treasurer** – shall collect and receive all monies and assessments and deposit them to the credit of the Confederation in a bank approved by the Confederation Board of Directors; shall render a statement of accounts to the Confederation Board of Directors and to the Confederation membership At regular meetings; shall issue receipts for assessments upon request; shall challenge the right to vote of any Confederation member not in good standing at the time of any vote by reason of being in arrears in payments of assessments; shall present a financial report in writing at the Annual Meeting; and shall keep a list of all Confederation members currently in good standing. The Treasurer shall be responsible for preparing the annual budget, to be approved by the Confederation members at the November meeting of each year. The Treasurer shall disburse funds that are included in the budget line items upon presentation of adequate documentation for such items.

**At-Large Board Members** – shall be chairpersons of Ad Hoc Committees of the Confederation as formed at the discretion of the BOD. They shall be eligible to assume the terms and duties of Confederation officers, if such officers resign, refuse, become ineligible, or are otherwise unavailable to fulfill their terms. At-Large Board Members shall be empowered to vote in all decisions of the BOD. If any elected Director is not able for any reason to complete a term of office, the BOD may appoint an Associate Director to serve as a Director until the next annual election and any individual so appointed shall be empowered to serve and perform their duties upon appointment.

All member associations in good standing are eligible to cast a vote in this election. To be considered in good standing, member associations are to be current in their annual dues. ## **Homeowners Legal Update- Closing Letters**

Per the Illinois Condominium Property Act, closing letters provided by an association as part of the sale of a unit by an owner (not the developer), should include:



- (1) A copy of the declaration, other instruments and any rules and regulations.
- (2) A statement of any liens, including a statement of the account of the unit setting forth the amounts of unpaid assessments and other charges due and owing.
- (3) A statement of any capital expenditures anticipated by the association within the current or succeeding 2 fiscal years.
- (4) A statement of the status and amount of any reserve for replacement fund and any portion of such fund earmarked for any specified project by the board of directors.
- (5) A copy of the statement of financial condition of the association for the last fiscal year for which such a statement is available.
- (6) A statement of the status of any pending suits or judgments in which the association is a party.
- (7) A statement setting forth what insurance coverage is provided for all unit owners by the association.

(8) A statement that any improvements or alterations made to the unit, or any part of the common areas assigned thereto, by the prior unit owner are in good faith believed to be in compliance with the declaration of the master association.

Our understanding is that this information is applicable to mandatory associations and those boards may wish to review these requirements with their legal counsel to ensure they remain in compliance. The Confederation is planning to provide association legal updates as part of our April 15th meeting.

## **NAHC Briefs – News You Can Use!**

Effective Monday, February 1, 2010, Metra will institute the following fare increases:

- A one-way ticket from Naperville to Chicago will increase to \$5.
- A one-way ticket from Route 59 to Chicago will increase to \$5.50.
- Weekend fares to Chicago will increase to \$7. Weekend passes are good for unlimited rides on both Saturday and Sunday for all stations.
- The penalty for on-board purchases will increase to \$3. This penalty is not assessed on passengers who board at unmanned stations.
- No fare increases will apply to the 10-Ride or Monthly Pass tickets.



Beginning Monday, February 8, 2010, on-duty agents at 76 outlying stations, including the Naperville and Route 59 Metra Stations, will accept payment for fares via credit card. Credit cards may also be used for online purchases of 10-Ride and Monthly passes.

In early 2010, Naperville will begin reconstruction of the **Jefferson Avenue Bridge**. The bridge, built in 1962, has reached the end of its life expectancy and is rapidly deteriorating. The closure date for the bridge is weather dependent. The new bridge is slated to open no later than August 27, 2010.

When complete, the new bridge will include two lanes, each wide enough to accommodate both vehicle and bicycle traffic, as well as protected sidewalks on each side for pedestrians. As part of the project, Jefferson Avenue will be reconstructed from Willoway Drive to Parkway Drive and a new plaza will be built to provide a northern gateway to the Riverwalk. The new gateway will include landscape enhancements, the Brethren Peace Plaza, bike parking and sitting areas.

During construction, the bridge will be closed to all vehicular and pedestrian traffic. Once a date for the bridge closure is confirmed, the City will provide notice including suggested detour routes and frequently asked questions. ## **Rental Housing Regulations**

City Council has directed that ordinances be prepared to regulate by whom, where, and how rooms and properties may be rented in areas zoned single family residential. As the NAHC is interested in hearing more about what problems neighbors are seeing, how this proposed regulation may address these issues, and whether neighbors and property owners really want or need a new layer of bureaucracy in their neighborhood, the Confederation hosted an open forum on the issues at its January meeting.



Among the information shared was a brief outline of the City of Aurora Property Registration program. Key points of this program include:

- All non-owner occupied single family residences, condominiums, and townhomes must be registered and licensed. All two-unit and multi-unit buildings must be registered and licensed.
- **Nonowner-occupied** units are inspected on an annual basis. Each year, exterior and interior inspections are performed
- A revised lease addendum needs to be signed by both the landlord and tenants upon new lease or renewal.
- Before you rent to a new tenant or before renewing an existing tenant's lease, you are required to conduct a criminal background check.

Several of the residents in attendance spoke in favor of an approach along these lines, particularly the need to better manage "bad actors" who may be renting next door. There was also discussion around apparent code violations and frustration with the code enforcement process. From the "landlord" side of the issue came concerns about added costs, bureaucracy, and a fear of being penalized for the actions of a few landlords seemingly driven more by profit than with concern for their neighbors.

What became evident from the discussion is that there will be no easy solution that will address the needs of neighbors, owners, and tenants. An ad hoc committee has been formed by the city that will include many community representatives, including the NAHC, to further investigate the situation and help propose workable solutions. ## **Free Home Energy Evaluation**

Whether because residents feel their houses are already energy efficient, are afraid to let a city inspector past the front door, or are daunted by the application process; the last time we checked the Naperville home energy savings program is only about two thirds of the way to its goal of 350 enrolled homes. Accordingly, the deadline has been extended.

Qualified residents 55 years of age and older living in a home within the Naperville city limits constructed prior to 1980 can apply for a unique opportunity to improve their home's energy efficiency. Thanks to funding from the Department of Energy, through the American Recovery and Reinvestment Act (ARRA), the City of Naperville is offering a FREE home energy evaluation by a certified energy technician.

Residents chosen to participate in the energy evaluation are eligible for a 50 percent reimbursement from the City of Naperville for energy improvements, up to a maximum of \$1,500. For more details go to [www.naperville.il.us/hesp.aspx](http://www.naperville.il.us/hesp.aspx).

By the way – the City assures us that this is not a building code inspection but rather a focus on energy issues only. The money and the opportunity are on the table – reach out to grab your share!

With just a few mouse clicks, Naperville's new HomeEnergyCalculator™ will analyze a home's current energy use and allow residents to simulate various energy savings measures to see corresponding dollar savings. 
