Zoning and Land Use Update



This report from the Confederation Zoning & Land Use Committee includes development and land use projects discussed at monthly NAHC meetings with City Staff, of interest to Naperville area residents, and/or under consideration by Plan Commission and Council. It also includes information obtained from other sources.

New Proposals: None

Ongoing Proposals:

Plan Commission at their August 18th meeting approved **Marquette Properties** proposal for two variations of their plan that, depending on economic conditions, will offer a seven-story, 130-room limited service hotel and 32 condo units in two five story buildings, or alternatively, 72 condo units, all in five story buildings. It is expected that City Council will take up the plan sometime in October. For more on the Confederation's take on this project, see the related article on page 6 of this newsletter.

Woods Along Old Plank Road: At its August 17th meeting, City Council approved, by a 5-3 vote, the controversial revised PUD for this site adjacent to Seager Park. The next step will be the vote for property annexation, probably later in September or early October.

12 N. Webster; The city has received a request for variances to construct a parking lot which encroaches into the required corner side yard setback (approximately 5') and to reduce the number of parking spaces required on-site from 25 spaces to 10 parking spaces in order to occupy the entire building with an office use (previous site approval included ground floor office and 2 upper stories of residential). To account for the difference in parking required vs. parking provided, the petitioner is working on potential solutions, including shared parking agreements with neighboring properties or buying-in to the City's deck. The case was originally proposed to go to the August 18th ZBA meeting, but the petitioner failed to provide required notice. The City did publish notice; accordingly, the case appeared on the August 18th agenda and was continued to the September 14th ZBA meeting. The City will publish again prior to the September meeting and the petitioner will give required notice.

Studies and Initiatives:

Plank Road Study (ROLC Zoning): The ROLC Zoning classification was the subject of a public hearing on August 18th before Plan Commission. This hearing was continued until September 1st. For more on the Confederation Board's views on ROLC, see page 4 of this newsletter.

Naperville Downtown 2030 plan: The Downtown Advisory Commission hosted its draft Downtown Plan update public open house on August 26, 2010. Notable issues are;

The downtown boundaries are expanding, including an area called "The North Downtown Special Planning Area" running from Benton to Douglas, west of Washington.

Building Height in the "Downtown Core" and the "Special Planning Area will have a limit of 60'. Thom Higgins, of the NAHC, has requested that staff modify Poster 11 to incorporate structures of that height (60') so as to give a more accurate representation of likely development in this area.

Various initiatives to make the pedestrian downtown environment more pleasant. These include;

1. Improved Crosswalks
2. Improving Alleyscapes
3. Creating Dual streetscapes and entrances in specific areas such as the north side of Jefferson between Washington and Main
4. Creating a "Festival Street" along Jackson, between Washington and Main.

In September, the Transportation Advisory Board (Transportation Recommendations, September 11, 8 AM) and Plan Commission (Land Use and Building Design Recommendations, September 15, 7 PM) will review sections of the Draft Naperville Downtown2030 Plan. Interested residents, property owners, business owners and other stakeholders are encouraged to attend and provide feedback. Both meetings are held in the Council Chambers of the Municipal Center.

Candidate Forums

The Confederation is planning to hold Candidate Forums for the upcoming November general elections later in September and in early October. Forums are being planned for County Representatives (DuPage and Will), statewide legislative offices (State House), statewide constitutional offices (Governor/Lt. Governor, etc). Federal Offices (Senate and US House 13th District), and the proposed referendums for City Council term limits and ward representation.

All forums will be broadcast live on the City Access Station, WCNC (WOW Channel 6, Comcast Channel 10, AT&T channel 99) and rebroadcast on NCTV Channel 17. There are five Candidate Forum dates. Sept. 23, Sept. 28, Sept. 30, Oct. 7 and Oct. 13. All will begin at 7:30 PM in the Municipal Center City Council chambers. Watch the Confederation website for more details on the who, what, and when of these valuable voter education sessions.

Homeowners Legislative Update

While unable to pass a balanced budget, the state legislature nonetheless had time to review the management and operation of homeowners associations. The Common Interest Community Association Act (P.A. 96-1400/SB 3180), the Homeowners' Solar Rights Act (P.A. 96-1436/HB 5429) and a revision to the Code of Civil Procedure (P.A. 96-1045/HB5509) were all signed by the governor and are now law in the State of Illinois.

HB 5509 provides that the notice of a judicial sale of a common interest community must contain a statement concerning liability for common expenses and enables non-condo associations to collect the last six months of assessments before a judicial sale. This was signed into law on July 14, 2010.

The Common Interest Community Association Act (SB3180) creates a framework for mandatory Homeowners Associations similar to that found for Condo Associations under the Illinois Condominium Property Act. By clarifying governance that was previously defined under not-for-profit organization rules, this bill will mandate changes in governance and notification, among other changes.

The Solar Rights Act (HB5429) requires mandatory HOA's to adopt "acceptable" design guidelines for the installation of solar panels on homes up to thirty feet (three stories) in height. It appears that no uniform design guidelines are proposed, and it will still be within the rights of HOA's, for example, to ban solar panels on the "street side" of buildings or to create guidelines on appearance, installation, maintenance, etc. While the environmentalist side sees this as a victory against "outmoded" HOA covenants and restrictions, the reality may be that this is just another opportunity for HOA's to exercise their rights to enact rules governing outside appearance within their community.

The NAHC is monitoring the impacts as well as proposed changes already being discussed for these laws. We will keep our membership informed as we learn more. If you have questions on how they may impact your association, you should discuss the matter with legal counsel.

ROLC Zoning Classification

The creation of the ROLC designation (Residential Office and Light Commercial) as both a land use designation and zoning ordinance has been recommended for areas in two recent studies: In the Plank Road Study, parcels on the west side of Naper both North and South of Plank Rd, and in the 75th Street Corridor Study, the South side of 75th both East and West of Wherli.

Plan Commission, at its Sept 1st meeting, will continue its examination of ROLC. The following is testimony that will be offered by a Confederation representative at that meeting;

"As the intent of the ROLC zoning district is that its use be limited to a small number of parcels i.e. portions along 75th and Naper Blvd, and possibly, in other limited areas of the city as well, the Board of the NAHC feels that this limited scope needs to be clearly articulated in the final ordinance so as to discourage developers from submitting development proposals requesting ROLC in areas not intended for this use.

One of the stated goals of the ROLC District is for structures within to act as a transition, and be respectful of the adjacent residential areas. In presentations by staff, illustrating existing preferred examples of office/commercial structures, all of the examples were of a strong residential style and scale comprising 1 to 2 floors and all utilizing gabled roofs. This is the only physical representation of preferred structures being presented to the public. We strongly agree with this, but fear that the actual proposed ordinance, allowing a 40' ht. limit without imposing any other conditions will result in squat rectangular, flat roof structures with 40' roof lines, and, we suspect, another 3' allowed for a parapet to hide mechanicals. This is clearly not in keeping with the goals clearly articulated in the study.

While we commend staff for revising the height recommendations to include a discussion about gabled roof structures, if in fact, gabled roofs are not a requirement that is of great concern to us.

Accordingly, the Board of Directors of the Naperville Area Homeowners Confederation requests that the ordinance clearly delineate that it is the intent of the district to be of a residential scale and style as was presented to the public as the goal of the ordinance, and that any structures built within the district conform to residential limitations including a limit of the number of floors (2 1/2) with the top floor contained in a gabled roof structure so as to remain sensitive to adjoining neighborhoods in form, scale and appearance. If these revisions are made part of the ordinance, the physical result will be structures constructed that conform to the illustrations staff offered as preferred examples of this use. "

National Preparedness Month



The City will host a National Preparedness Month Open House from 4 to 7 p.m. on Thursday, September 2 at the Naperville Municipal Center.

The open house will provide residents and businesses with the opportunity to tour emergency and disaster relief vehicles, including the DuPage Mobile Command Vehicle. Attendees can also learn about emergency preparedness for families, youth, seniors and persons with disabilities from the city's Community Emergency Response Team (CERT) and Naperville Emergency Management Agency (NEMA) volunteers. A question and answer session featuring Police Chief David E. Dial and Fire Chief Mark Puknaitis will take place from 5:30 to 6:30 p.m. in Council Chambers. Additionally, Special Weapons and Tactics (SWAT) team members will be on-site to display the elite paramilitary tactical vehicles and weapons they use.

The city has published an Emergency Preparedness Guide with helpful tips on what to do before, during and after an emergency. The guide lists examples of what to include in a family disaster supply kit, how residents can obtain notification during an emergency, how to store food and water in an emergency and more. The guide is available for download at www.naperville.il.us/emergencyprepguide.aspx.

Naperville Sidewalk Replacement Program

The deadline to apply for the City of Naperville 2011 Sidewalk Replacement program is October 31, 2010. Call (630) 420-6195 to apply. Residential property owners pay 40% of their replacement costs, based on the citywide negotiated contract. To qualify, one of the following conditions must exist:

- Walks must be sunken or risen to a height difference of one inch or more between sections;
- Broken or separated into three or more pieces;
- 50 percent or more of the sidewalk surface is deteriorated.



Depending on the extent of the damage, a sidewalk is either repaired or replaced. Applicants will be contacted by the City whether or not their sidewalk is eligible for the program. If your sidewalk qualifies, the City will send a letter outlining the program. If the sidewalk is not eligible, it may still be repaired with 100% of the cost paid by the property owner. The owner must pre-pay this amount.

Water Street Update

At its August 18th meeting, Plan Commission approved a revised proposal for development of Water Street. The NAHC, based on its 2007 membership vote,, expressed concerns with the new plan.

The revised project, with the potential addition of a hotel causing the Tower/Mixed Use building to grow by two additional floors, increases the NAHC's original concerns. One belief we have is that bigger is not better for this location. The charm and livability of the downtown is lost with the massive structures(s) being suggested in such a small area.

Briefly, the Confederation Board's concerns (some of which were repeated form 2007, others of which are specific to the new proposal) are;

a. The height and density of the project. At 7 floors the tower building will be 85' to 90' compared to 54' for the existing Moser building. This building, and it's attached 690 space parking deck is a massive monolithic structure that will dominate the skyline.

b. At 5 floors, the Loggia and Theater Buildings along the river overpower and commercialize the Riverwalk.

c. Narrowing the street/sidewalk from the standard 66' to 57' has numerous and significant negative implications for traffic, and especially, for pedestrians.

d. The potential traffic/safety problems from constructing a very large, busy, parking deck, whose only access/egress is a 20' wide alley. An additional concern is the fact that the deck will certainly have to share spaces with any redevelopment along Aurora.

e. A private pedestrian skyway across publicly owned Water Street right of way for the sole use of 20 luxury condo owners to the North further "canyonizes" an already narrow street, obstructing views.

f. With 3 years of the 23 years on the TIF already expired, what will be the financial effect of an extended construction timetable further reducing the TIF's life? Will the Tower/Mixed Use building be able to service the TIF's financial requirements on its own?

g. Is a hotel financially viable in this economic climate? An article in **Crain's** (8-25) discussed the "brutal downturn" in hotel business that led three Chicago area hotels to fall seriously delinquent in their mortgage payments. How can Naperville be assured that it will not be "left holding the bag" financially, if a hotel fails there?

h. The same concerns can be voiced on the fall back position of constructing condos in lieu of the hotel. There market is questionable for additional condo's downtown currently, with other condo projects already approved for the downtown area. Again, as the developer is utilizing a TIF for this project, what guarantees can the city receive that the condo proposal will ensure repayment of all TIF funds expended by the city for infrastructure?

NAHC Briefs – News You Can Use!

The Department of Public Utilities – Electric (DPU-E) is conducting **citywide meter surveys** to determine existing meter violations, broken meter troughs and/or broken meters. It is essential for DPU-E personnel to have the required clearances in order to safely work on electrical equipment. Obstructions cause safety issues and delays in restoring electric service.

Surveying began in mid-July and more than 1,500 violations have already been identified. Inspections are slated for completion by mid-September. A majority of the violations involve access to the meters being blocked by plants, bushes, trees or decks. Residents or businesses found in violation receive written notification from the city at the residence or place of business allowing 60 days to resolve the situation. DPU-E employees inspecting these violations will also attempt to contact the owner of the residence or business in-person to suggest solutions for the violations. Residents or business owners can call the Naperville Smart Grid Initiative (NSGI) hotline at (630) 420-6131 for solution recommendations. If violations are not resolved within the 60 day period, Code Enforcement will issue a citation requiring the violator to appear in court and potentially be assessed a \$50 to \$500 fine each day the violation remains.

Petitions for candidacy for the 2011 Naperville municipal election are available in the City Clerk's Office at the Municipal Center, 400 S. Eagle St. Expiring positions include one four-year position for Mayor and four four-year positions for Councilman. To qualify as a candidate you must be a registered voter of the City of Naperville and have resided within the corporate limits of the city for at least 1 year.

Petitions for nomination are filed with the City Clerk's Office. The filing period will take place from 8 a.m. to 5 p.m. Monday, November 15, 2010, through Monday, November 22, 2010, excluding weekend days.

A Consolidated Primary Election will be Tuesday, February 22, 2011, if more than 4 candidates file for any one office. The Consolidated General Election will be Tuesday, April 5, 2011. For more information regarding petitions for candidacy, please contact the City Clerk's Office at (630) 305-5300.

As students begin the school year, the City of Naperville and Naperville Police Department ask that parents and residents make back-to-school safety a priority.

During the first days of school, be sure to talk to your children about the following safety rules:

- Use the buddy system. Always walk to and from school with a friend or stay with a group at the bus stop. There is safety in numbers.



- Walk/ride in well-lit areas and never take shortcuts. Instruct children to avoid places where they cannot be seen or heard and to stay on the “Safe Routes to School.” These routes may be found on the city’s website at www.naperville.il.us/walkroutes.aspx.
- Walk to and from school with your child to help familiarize him/her with the walk route. Be sure to point out “Helping Hand” houses along the way. “Helping Hand” households are safe places for children to go when they need emergency adult assistance.
- Stay within the crosswalks and obey all traffic signals/signs. Obey the crossing guard, if one is available. Parents should make sure that their children know how to safely cross the street. In the case of younger students, always provide supervision to help ensure their safety. If children ride their bikes to school, ensure they wear their helmet at all times, provide them with a bicycle lock and be sure they use the lock.
- Teach children the safety rule “Say NO, GO and TELL.” If anyone approaches your child, offers him/her a ride, asks for directions or makes him/her feel uncomfortable, instruct them to say “no,” get away from the situation (“go”) and “tell” a trusted adult. Be sure to discuss with your child who trusted adults may be, such as teachers, parents, friends’ parents, neighbors, police officers, firefighters and relatives.
- Have a family password. Teach your children that they can’t go anywhere with anyone (even a relative) without your permission, unless the person coming for them knows the family password. Practice situations so that your children understand the kinds of circumstances in which a person who doesn’t know the password might be persuasive. Even if someone tells your children they must come along because their parent is in the hospital, they should ask for the family password. Make sure your children have not told anyone the password. Also, make sure your children understand to never leave school with anyone they haven’t been instructed to leave with.
- If your children will be taking care of themselves after school, please provide them with additional safety rules. These may be found on the city’s website at www.naperville.il.us/onyourown.aspx.

Construction Updates - On Monday, August 30, 2010, work began to resurface **95th Street** from Naperville-Plainfield Road to IL Route 59. During construction, traffic will be reduced to one lane in each direction from 7 a.m. to 5 p.m. Motorists are advised to seek an alternate route to avoid delays. The project is slated for completion in mid-October.



Construction on the **75th and Washington** Intersection Improvement Project has resumed following the resolution of the recent three-week union labor strike.


However, the strike and the recent rain and river flooding have caused a slight delay in the overall project timeline. The city's contractor is working extended hours on weekdays, whenever possible, to make up for time lost.

In October, all lanes are expected to open in the evenings and on weekends on both 75th and Washington streets. Final paving will occur throughout the weekdays and require intermittent daytime lane closures. All aspects of the project, including roadway work, sound walls and landscaping are still slated for completion in early 2011.

Due to delays caused by the recent union labor strike, as well as the recent weather, the **Jefferson Avenue bridge** opening is now slated for completion in early September.



Bicycle Safety Tips from the Naperville Police Department

Bicycling is a fun activity and a great way for residents to become and remain fit. The Naperville Police Department would like to encourage all bicyclists to stay safe while riding. Bicyclists can be seriously injured in accidents because they are less protected than drivers of automobiles and do not always practice safe riding skills. Be sure to take the time to always wear a helmet, to learn the rules of the road and obey all traffic laws, be visible and predictable while riding, and lock up bikes not in use.

The Naperville Police Department recommends the following bicycle safety tips:

- Wear a bike helmet at all times.
- Wearing a bike helmet can reduce the risk of head injury by 85 percent.
- Keep your bike in good working condition.
- Be sure tires are properly inflated, brakes work, and the chain is well oiled
- Ride single file on the roadway
- Slow down and check traffic at all corners and intersections
- Keep both hands on the handle bars except when indicating turn signals
- Stay off busy streets Have a headlight on your bike when riding at night, as well as, rear and wheel reflectors
- Wear light colored and/or reflective clothing while riding
- Only one person on the bike with no stunt riding
- Do not carry packages or bundles when riding
- No hitching rides from cars
- Do not wear headsets while riding
- Always yield to pedestrians



Safeguard your bike by registering it in case of loss or theft. Unfortunately, many bicycles recovered in never find their way back to their owners because the bikes were not registered and therefore, the owners could not be found. You may register your bicycle at the Naperville Police Department by providing us with the make, model and serial number of the bike. There is a one dollar registration fee.

Don't forget to always secure the bike when finished riding. Be sure to keep the bike in a closed and locked garage. Never leave it unattended on the driveway, front or side lawn, or blocking a sidewalk. Invest in a good lock and faithfully lock the bike to an immovable object, such as a lamp pole or bicycle rack, in an open and well-lit area. Do not lock your bicycle to small trees, aluminum or wooden posts, or chain link fences. These can be cut or broken. Furthermore, do not lock a bicycle to itself (front wheel locked to the frame) as a thief can simply carry it away.
