#### **President's Letter**

As the Confederation begins its 31<sup>st</sup> year, I'd like to thank all the Board members who have served over the decades. We really have evolved into a group of neighbors helping neighbors. Our monthly meetings, once again held on the third Saturday, are designed to be thought provoking. September featured two areas of community interest: electric energy and Water Street redevelopment.

The future of electric power was covered during a discussion of the Smart Grid initiative. The take home message was assured reliability and cost management. For homeowners, one can choose to utilize the features of Smart Grid or continue using power as today. It's your choice. Due to better power management, the Smart Grid will afford us a less expensive means to operate our homes.

The serious discussion of Water Street led to a motion to go on record opposing the revised concepts recently approved by Plan Commission. Why the strong outpouring of opposition? Mainly the enormity of the proposed structure and, if built, how completely out of character massive buildings that dwarf City Hall will be in our downtown. Confederation original concerns focused on plans that made the new structures the size of the existing Moser building. Rather than rework those troublesome plans, the developer added 3 more stories to the structure, incorporating a 150 room hotel with twenty \$1.5 million condos.

Simply speaking, the Confederation is requesting a careful review of this project to better reflect actual economic conditions. There are already unsold million dollar condos available in our City. The hotel concept is interesting but does it need to be 150 rooms? Is there a sound economic model for either condos or a hotel?

Bigger is not always better. We ask City Council to resist the speculative temptation of future tax money. We ask for a well-planned downtown based upon reasonableness, not raw speculation. It can only be built once.

### **Zoning and Land Use Update**



This report from the Confederation Zoning & Land Use Committee includes development and land use projects discussed at monthly NAHC meetings with City Staff, of interest to Naperville area residents, and/or under consideration by Plan Commission and Council. It also includes information obtained from other sources.

#### **New Proposals:**

**Coopers Hawk:** A wine bar and restaurant chain is planning to construct a facility on the east side of Freedom Commons Rd. just north of Diehl.

**Carillon Club;** is requesting a minor change to their PUD. They are requesting to delete the plan to build 5 condo buildings and build townhomes instead.

#### **Ongoing Proposals:**

**Water Street Development**; Plan Commission at their August 18<sup>th</sup> meeting approved Marquette Properties proposal for two variations of their plan that, depending on economic conditions, will offer a seven-story, 130-room limited service hotel and 32 condo units in two five story buildings, or alternatively, 72 condo units, all in five story buildings.

Some aspects are still under review by staff, including the desirability of having the 700 stall parking deck empty onto to a 20' wide alley. No date has been set for its appearance in front of City Council. For more information, see page 6 of this newsletter

**12 N. Webster**; The petitioners request for variances was to have been continued to the October ZBA meeting, however that meeting has now been cancelled. We will assume that it will be in front of TAB for the November 6<sup>th</sup> meeting. They are requesting variances to construct a parking lot which encroaches into the required corner side yard setback (approximately 5') and to reduce the number of parking spaces required on-site from 25 spaces to 10 parking spaces in order to occupy the entire building with an office use (previous site approval included ground floor office and 2 upper stories of residential). To account for the difference in parking required vs. parking provided, the petitioner is working on potential solutions, including shared parking agreements with neighboring properties or buying-in to the City's deck. **Woods Along Old Plank Road:** At its August 17<sup>th</sup> meeting, City Council approved, by a 5-3 vote, the controversial revised PUD for this site adjacent to Seager Park. The annexation agreement was scheduled to be heard at the September 21<sup>st</sup> and then rescheduled to the October 5<sup>th</sup> City Council

meeting has been removed from the schedule.

#### Studies and Initiatives:

Naperville Downtown 2030 plan: currently in the "land Use" review phase. Notable changes to the existing plan are the increase in both the height allowed for structures (60') and in the downtown area The plan envisions expanding the downtown core northward across Benton all the way to Douglas. Further, this area has been designated a "Special Study Area" with the planning to resemble the Water Street redevelopment effort. The plan talks about encouraging a large "anchor" or "destination" use (hotel, museum, movie theater, large retailer, etc.), and is willing to allow heights even taller than 60' here. The plan shows potential intensive uses all the way north to Douglas where they would face Washington Junior High School.

Another area where the plan again pushes into residential districts is in the Naper Elementary School area, namely, Jefferson Avenue (between Mill Street and Eagle Street) and Webster Street (between Douglas Avenue and Benton Avenue) where, quoting



the draft plan it states; "Moving forward, consideration may be given to alternative uses for these blocks based on the presence of office, commercial, and institutional uses in the immediate vicinity of each. Uses such as low intensity home-to-office conversions (which require review through a public hearing) may be appropriate for consideration on a case-by-case basis". There is a discussion in the draft plan regarding FAR (floor area ratio) which has become a contentious issue as parking decks, constructed as part of a private enterprise endeavor are seen (for the purposes of calculating FAR) as open space. This explains why the proposed Water Street project, which includes a seven story

hotel/parking deck, can have a calculated FAR under 2.5, thus illustrating the numbers lack of real world relevance when compared to say, Main Street Promenade, that at 3 floors has a similar FAR but is a much smaller structure and presence.

Notable for its absence, is the lack of any discussion of the desirability of limiting the size and intensity of use in the downtown area due to the adverse impact large scale re-development will have on the existing, already overburdened transportation system.

The Naperville Plan Commission is still accepting public comments on the supplemental Downtown Building Design Standards Manual and the Land Use Section of the Naperville Downtown2030 Plan. Residents, business owners and other interested stakeholders are encouraged to attend the Plan Commission meeting on Wednesday, October 20 to provide additional comments on the manual. **ROLC Land use and Zoning Designation.** City Council conducted the first reading of the proposed ROLC ordinance on Sept. 21<sup>st</sup>. Council members posed a number of questions as to the need for the ordinance, setbacks proposed, and how to ensure commercial structures reflect a residential style and scale. The NAHC Board offered the following testimony on the proposed ROLC zoning district:

**INTENT:** While the staff memorandum and Intent section of the proposed ordinance explicitly discuss the 75<sup>th</sup> St. and Plank Road Study areas, staff has acknowledged that, if enacted, developers would be free to request ROLC designation in other areas. Additionally, there is already informal discussion of other areas where ROLC might be applied. Therefore, we believe that since it is to be allowed in more than the two identified areas, consideration of ROLC zoning requirements such as setbacks and rooflines must be carefully scrutinized by Council during this stage of its adoption as the potential impact of ROLC zoning will be to the City as a whole and not just the two areas specifically discussed in the staff memorandum.

**SETBACKS:** We question the reduction in depth of rear yard setbacks allowed for ROLC properties, since these properties are currently zoned residential and the proposed district encourages residential use as a right. At 15', they are less than the currently required 25' setback for all residential rear yards. If ROLC zoning is approved, the 15' setback currently proposed in the ordinance for all uses would provide less of a buffer for residents abutting these properties than required by the original residential zoning, negatively affecting the residentially zoned property owner. Residents should be able to know that existing rear yard setbacks of 25' would continue to apply in the ROLC zoned areas irrespective of use.

RESIDENTIAL SCALE AND CHARACTER: We feel staff has shown great willingness to work with residents so that office/commercial structures are residential in scale and character. Our two suggestions are:

1. Stipulate that roofs must be pitched, as a developer could conceivably construct a 35' tall, 3 story, flat roofed structure with some vaguely "Prairie Style" elements and claim they satisfy the requirement. Note that all illustrations show to the public were of 1 story, pitched roof, structures. However, during further discussion with Allison Laff of TED indicated that flat roofs would also be allowed. We do not believe that this contributes to a building that has a residential character and scale.

2. Amend Naperville's Building Design Guidelines to include a section discussing Naperville's vision of how commercial structures in areas such as these abutting residential homes should, in design, scale, and character, truly act as a transition to these residential areas. We find that the one sentence in A2.1 is inadequate to this task.

**Metra Station Bus Depot and Commuter Access Feasibility Study**; The city is planning to conduct this study during the 2011 calendar year and has sent out an RFP (request for proposal) for a consultant to work on the study along side City staff. Additionally, the city is seeking funds from the RTA to pay for 80% of the cost. A decision by the RTA is expected by December of this year. The Confederation Board contacted the RTA and urged approval of these funds.

### **Candidate Forums**

The Confederation held candidate forums in September for DuPage and Will County Board candidates and to look into the issues around the referendum questions for City Council term limits and district representation. Thanks to all of the candidates, panel members, and volunteers who helped make these a success.

The law states that while driving in Illinois, all drivers must stop for pedestrians in all crosswalks. Even if the crosswalk is unmarked, does not have a stop sign or traffic signal, the driver must yield to the pedestrian so that they may cross safely. With a reported 6000 pedestrian related accidents across the state each year by the Illinois Department of Transportation, the failure to yield to offense now has a minimum

penalty of \$120.00 dollars.

## Naperville Sidewalk Replacement Program

The deadline to apply for the City of Naperville 2011 Sidewalk Replacement program is October 31, 2010. Call (630) 420-6195 to apply. Residential property owners pay 40% of their replacement costs, based on the citywide negotiated contract. To qualify, one of the following conditions must exist:

- Walks must be sunken or risen to a height difference of one inch or more between sections;
- Broken or separated into three or more pieces;
- 50 percent or more of the sidewalk surface is deteriorated.

Depending on the extent of the damage, a sidewalk is either repaired or replaced. Applicants will be contacted by the City whether or not their sidewalk is eligible for the program. If your sidewalk qualifies, the City will send a letter outlining the program. If the sidewalk is not eligible, it may still be repaired with 100% of the cost paid by the property owner. The owner must pre-pay this amount.

## **Water Street Update**

At our September 18<sup>th</sup> meeting, Confederation Associate Director Thom Higgins presented an update on the proposed changes to the Water Street Redevelopment project. Following the presentation, a motion was made from the floor and unanimously passed for the NAHC to refresh its opposition to these developments, as originally stated in our 2007 membership vote and

Public Stand, by incorporating opposition to the even taller buildings now proposed.

Accordingly, and following member notification requirements within our bylaws (assume that this article is the required notice), the NAHC will vote at our November 20<sup>th</sup> meeting to express our opposition to this project because: Briefly, the Confederation Board's concerns (some of which were repeated form 2007, others of which are specific to the new proposal) are;

a. The height and density of the project. At 7 floors the tower building will be 85' to 90' compared to 54' for the existing Moser building. This building, and it's attached 690 space parking deck is a massive monolithic structure that will dominate the skyline.



- b. At 5 floors, the Loggia and Theater Buildings along the river overpower and commercialize the Riverwalk.
- c. Narrowing the street/sidewalk from the standard 66' to 57' has numerous and significant negative implications for traffic, and especially, for pedestrians.
- d. The potential traffic/safety problems from constructing a

very large, busy, parking deck, whose only access/egress is a 20' wide alley. An additional concern is the fact that the deck will certainly have to share spaces with any redevelopment along Aurora.

- e. A private pedestrian skyway across publicly owned Water Street right of way for the sole use of 20 luxury condo owners to the North further "canyonizes" an already narrow street, obstructing views.
- f. With 3 years of the 23 years on the TIF already expired, what will be the financial effect of an extended construction timetable further reducing the TIF's life? Will the Tower/Mixed Use building be able to service the TIF's financial requirements on its own?
- g. Is a hotel financially viable in this economic climate? Is there a market for additional luxury condominiums? How can Naperville be assured that it will not be "left holding the bag" financially and aesthetically, if the project fails to provide adequate return on investment?

Quite simply, we believe that bigger is not better for this location. The charm and livability of the downtown will be lost with the massive structures(s) being suggested in such a small area.

The pictures included with this article are part of a series of black and white drawings provided to the NAHC by City staff (after the developer refused to provide them to us because "...the last time we made a presentation to you. You betrayed our trust by using those documents to arm your attacks on the project. So although we'd like to help you in providing information to your group, we can't in good conscience believe that the info won't be used against us and the project.")

Needless to say, we haven't made changes to the documents, just shared them as presented because we think that they truly speak for themselves. ## **Keeping Tabs on Technology**

Growing up, most parents today didn't have cell phones, text messaging, or email. But lots of us did have our own phone lines, and made calls to formal or informal hotlines for information on everything from movie times to the location of the best weekend party to crisis counseling. Our own parents had their "new" technologies, too. And none of it was good or bad; it was simply different from that of previous generations.

It's up to us as parents now to figure out how to help our kids navigate their world by being knowledgeable, involved, compassionate, and curious about how they socialize, recreate, and get information through the latest technology.

#### Here are some examples of what we mean. Try it...

#### For parents with children ages birth to 5

- Pay attention to the messages you model—stay off the cell phone, personal digital assistant (PDA), and other electronic devices when you're driving or engaged in other activities that deserve your full attention.
- When you're spending time with your kids, turn off the devices. That's what
  voice mail is for! Your kids need, want, and benefit from your full attention.

#### For parents with children ages 6 - 9


- Make sure your kids know what your limits are for cell phone, computer, and other device usage. Many, for example, know (or can figure out) how to access the Internet to play games online or on cell phones and PDAs.
- Don't let your kids use the Internet unattended. It's easier and more practical to monitor their usage if you have the
  family computer set up in a common space in your home. You can "watch from afar" or just regularly glance over to
  see what they're up to.
- Online social networking communities such as MySpace and Facebook are very popular, even with elementary-age
  kids. If your kids use these sites, know whom they allow access to on their pages and make sure they know why
  you've set up limits on this access.

#### For parents with children ages 10 - 15

- Let your kids know that you will regularly check their e-mail, phone, and text messaging content on both incoming
  and outgoing lists, and that they should limit those lists to friends and family members, not people they meet online.
   If you see names you don't recognize, find out who they are and how your child knows them.
- Have rules about when and where your children and you will use handheld communication devices. Suggestions
  include not using them at mealtimes, when visiting family or friends, when driving or operating other machinery, or
  when in the middle of another conversation.
- . Know the school rules for cell phones in class, and consider limiting their use to before and after school only.

#### For parents with children ages 16 - 18

- Understand that regardless of the way you use technology, it's part of how young people today build their social networks and their community. Be sure that your teens understand the degree of public and private access that others have to their communications. Talk with them about what's inappropriate to share publicly, and why.
- Keep computers out of teens' bedrooms and in central family areas of your home.
- Let your teen know that some employers and colleges search the Internet for information related to applicants who apply to their institutions. Discuss the kinds of information that may compromise their chances of acceptance.
- Find out what technologies are being used in your teen's school. Do teachers keep blogs? Are student groups organized on MySpace or Facebook? Do teachers use digital whiteboards? If so, check these out periodically.

### **Electronic Device Registry**

In a proactive response to reports of lost or stolen items at local schools, the Naperville Police Department is partnering with Indian Prairie School District 204 and Naperville School District 203 to offer a free and voluntary registry for electronic devices brought to or used at school.

All District 203 and 204 students, parents, and staff members are encouraged to register common electronic devices, such as calculators, cameras, cellular phones, laptop computers, MP3 players and GPS units. The Naperville Police Department School Resource Officer Unit, through the City of Naperville, will maintain the registry and use it to identify and investigate lost, stolen, or recovered devices, with the emphasis on reuniting lost or stolen property with the rightful owner. Students, parents and staff members of all Districts 203 and 204 schools can use this free registry.



The registry is available at <a href="http://bit.ly/devicereg">http://bit.ly/devicereg</a>. It is also available by visiting the City of Naperville's website at <a href="https://www.naperville.il.us">www.naperville.il.us</a> and clicking "Citizen Support" in the top tool bar and "Submitting a Request" on the following screen, followed by clicking on "Electronic Device Registration."

Once a device is registered, the user will receive an email confirming the registration, as well as vital information regarding the specific manufacturer, model, and serial number. It is recommended that you retain this information for your own files. Please make sure to provide a phone number, in addition to an email address, so you can be contacted in the event your property is located.


