We invited Naperville Finance Director Karen DeAngelis to join us this month and provide an update on Naperville's City Budget for fiscal year 2012. While there has been some good news lately on the revenue side, Council's directions to hold the line on property taxes coupled with less income from new developments and the pension elephant hiding in the corner continues to make a balanced budget a work in process.

Zoning and Land Use Update



This report from the Confederation Zoning & Land Use Committee includes development and land use projects discussed at monthly NAHC meetings with City Staff, of interest to Naperville area residents, and/or under consideration by Plan Commission and Council. It also includes information obtained from other sources.

Change in Boards and work efforts:

Plan Commission - Zoning Board of Appeals: Planned to take effect in May 2011, the ZBA (Zoning Board of Appeals), will be dissolved and the Plan Commission will take over its duties. It is expected that Plan will remain a nine member board with the possibility of a ZBA member moving over to fill the one Plan Commission seat that is currently vacant, and possibly replace some current Plan members when their term expires. Staff indicates that the change is expected to save \$17,000 annually.

There are a number of concerns that have been voiced regarding the change. ZBA spends the majority of its time evaluating signage variance requests. If Plan Commission members are to take this over, there will need to be extensive training in order for them to be able to properly evaluate such requests. Additionally, there is the time issue: can all petitioners' requests receive the time they deserve with a combined board, without having the kind of marathon meetings that is typical of City Council? Lastly, comments have been made that the planning discipline of Plan Commission does not fit all that well with the regulatory discipline of the ZBA. Stay tuned.

TED Long Range Planning: The Transportation Engineering and Development Dept has indicated they have cut their long range planning initiatives by 50%. Some of the ramifications are:

- Eliminating new studies and major zoning amendments, including the Tollway Corridor Study, Mill & Bauer Small Area Study, Mixed Use Text Amendment (resulting from the 5th Avenue Study), and Single-Family Residential Tree Preservation Requirements.
- Focusing on the implementation of action items resulting from recently adopted plans, namely Naperville Downtown2030, Attainable Housing, Greener Business Program, and Downtown Restaurant/Bar Mix.

- Evaluate "quick fixes", such as the creation of a height overlay in the zoning ordinance, which can be used to achieve the most critical recommendations of the 5th Avenue Study without undertaking the Mixed Use Text Amendment.
- Evaluate development requests on a case-by-case basis using information available at the time of submittal.

Of significance is the decision to not go forward with a "Mixed Use" zoning classification, and instead rely on existing ordinances. The likely outcome of this is developers interested in building Mixed Use projects in the Downtown area will submit as a PUD (Planned Unit Development) where each proposal is judged on its own merits, case by case. However, there will not be any clearly defined parameters of what characteristics Naperville considers a Mixed Use development should embody for Plan Commissioners or City Council members to compare a proposal to.

There is a desire to revise the TU zoning classification as there is agreement that it has not worked as intended. Revising it will occur in 2012 at the earliest. There are no current plans to revise the OCI zoning ordinance.

New Proposals:

New Multi-tenant Retail Building: A 10,000 square foot multi-tenant retail center proposed for the vacant lot located immediately south of the Jewel Express Gas Station at 95th Street and Route 59 received approval at the Jan 19th 2011 Plan Commission meeting with a variance to allow parking 3' into the setback. It is expected to be in front of Council sometime in March. Tenant's will include 5 Guy's, Chipotle and a Cellular provider.

Primrose School: Will be before the Plan Commission in Feb-March to construct a day-care pre-school south of the Theater at Naperville Crossing on Rt 59.

Gordmans: is moving into the space formerly occupied by Cub Foods at 59 and Aurora. Who are they? Check out <http://www.gordmans.com>

Washington Street Post Office: From a [Naperville Sun](#) article: Naperville Bank and Trust announced that it is under contract to purchase the more than 70-year-old building at 5 S. Washington St. As part of the plan, the Postal Service would lease back 2,000 square feet of the building and continue to provide service at the site. Bank officials said the process of getting permits and approval for the project from the city of Naperville has already begun.

According to bank leaders, the historic façade and interior of the post office building would remain intact. The facility would include a full-service bank, with a 24-hour ATM.

Ongoing Proposals:

Dick's Sporting Goods: Received approval from City Council on Jan 18th for a new 50,000 square foot building is proposed to be constructed on the west side of Springbrook Prairie Pavilion (Center at 75th Street and Route 59, near Whole Foods). Site-work is expected to start soon.

Studies and Initiatives:

Naperville Downtown2030 plan: Residents have until Feb 14th to offer comments on the plan. On December 9th, DAC approved a final recommendation on Draft of *Naperville Downtown2030* (incorporating feedback received from DAC, PC, HPC, Advisory Commission on Disabilities, and CC. The draft is now posted on the city's webpage at: <http://www.naperville.il.us/napervilledowntown2030.aspx>



City Council review is anticipated in March 2011.

District 203 & Your Tax Bill

Here are a few comments on property taxes for D203 taxpayer's and the impact various TIF's may have. Questions should be directed to District 203, not the Confederation.

SD203, like other state school districts, tax increases are governed by PETL, better known as the Tax Cap law. This limits operating levy increases to the increase in the Consumer Price Index or 5%, whichever is less. For the 2010 tax levy the limiting CPI is 2.7%. The District cannot increase your property tax bill more than 2.7% (in aggregate). Additionally, by voting to approve the facilities referendum SD203 taxpayers authorized the District to increase our taxes to pay off \$43M in bonds. The Debt Service Levy to pay off those bonds is approx \$3M annually.

For the 2010 levy two possible abatements are being proposed, a \$440,000 abatement due to the Navistar TIF and an abatement of the remainder of the Debt Service Levy.



Navistar TIF:

The reduction to the Debt Service Levy in the amount of \$440,000 would be a voluntary action on the part of the School Board. There is a recommendation to take this action predicated upon the Village of Lisle finalizing a Bond Abatement ordinance based on the Redevelopment Agreement entered into by Navistar and the Village of Lisle that agrees to distribute a portion of the TIF proceeds each year to the underlying taxing bodies.

The District will have to pass an Abatement Ordinance each year to keep abating this amount. It is logical to do this as long as the TIF distribution is made. The Debt Service Levy will expire when the \$43 million bonds are paid off with the 2027 tax levy. Assuming the TIF distribution continues to be made, we could see this potential abatement through 2027.

The rationale for using the Debt Service Levy (DSL) to abate this \$440K is it allows the District to reduce current taxes without impeding future tax levies. If the District reduced the Operating Levy by the \$440K, that would play into the Tax Cap formula for all future years – including any year that there might not be a distribution from the TIF and all the years beyond the TIF dissolution. While it is unlikely that there would not be a distribution from the TIF, it is possible.

Debt Service Levy:

There is also a proposal to abate the remaining Debt Service Levy for 2010, roughly \$2.6 million. We suspect this will not be decided until March when the Board has to approve the final Levy. The hope is that by then there will be some clarity on State funding for the District, although it is anybody's guess how Illinois will resolve its education funding issue. Our recollection is that the current 203 projection is based on a 30% reduction in funding. If 203 get's something close to that from the State, they could abate the remaining DSL.

The bottom line is SD203 can, under the Tax Cap law, increase their operating Levy by 2.7% and keep the Debt Service Levy intact. This means property tax bills will increase 2.7%. If both abatements are approved, and the Board of Education decides the DSL should be abated in its entirety, the result could instead be just a 1.1% increase. Of course, if SD203 abates based on promised State funds, they could be the only school district in Illinois choosing to follow this course of action.

There is also the expiring Cantera TIF which will bring additional funds to the District. Initially, 203 targeted those funds to pay off Tax Anticipation Bonds that were to be used to fund part of the facilities effort. The District has now chosen to fund that \$36M amount from operating funds, which will save on interest costs. As such, Cantera TIF money is now planned to maintain the operating fund account.

Bottom line – SD 203's portion of our Real Estate Tax bills will definitely increase, the final amount is yet to be determined by the District 203 Board of Education.

Here, residents may discard lights that no longer work during normal hours of operation on Tuesdays, Thursdays and Saturdays from 8 a.m. to 4 p.m. through March 15, 2011.

- rope
- LED
- extension cords

Raising Responsible Kids

You want your child to clean her room, but it's a disaster. You ask your child to put his clothes into the hamper, but instead they're strewn all over his room. How can you get your child to take responsibility when he or she refuses to accept it?

Here are some examples of what we mean. Try it...

- Know that teaching kids responsibility takes a long time. Don't expect sudden miracles. Continue to talk and teach about responsibility as your child grows.
- Make sure your child feels the consequences of not taking responsibility (instead of you feeling the consequences). For example, if your child refuses to place his clothes in the hamper to be washed, leave them on the floor of his room. Don't wash the clothes. When your child panics about not having clean clothes, show him the way to the washer and dryer.
- Resist the temptation to rescue your kids when they suffer the consequences of not taking responsibility. If your teenager calls from the library in the middle of winter wanting a ride home because she's cold and she didn't wear a coat, empathize with her situation, but don't bail her out (unless it could be a life threatening situation).
- Talk less. Kids often refuse to take responsibility because they know their parents will keep reminding them to do so. Be clear that you'll give ONE reminder, and then it's up to them.
- Lead by example. Remember that lessons in responsibility always start with you! If your child hears you saying one thing and then doing the opposite, your kids will be more likely to follow your example rather than follow your command.

Parkway Temporary Signs

Earlier this year, as part of their normal duties, Naperville Code Enforcement pulled a sign out of the right of way (effectively the parkway area between the sidewalk and street) advertising a homeowners' association meeting. According to City Staff, code officers and inspectors annually pull around 6,000 illegal signs in the right-of-way in their normal course of traveling through the city..



The NAHC and Councilman Doug Krause spoke with City staff and we were advised that City Code does not allow anyone to put signs in the right-of-way, and exempting one user (such as an HOA publicizing an event or a meeting) from that ordinance is not possible.

The only solution is for residents to put their signs (such as those advertising homeowners' association meetings or garage sales) on private property. As guidance, signs should be placed behind the sidewalk or at least ten feet behind the edge of pavement if there is no sidewalk.

With the election season upon us, it is understandable why it is important to keep clutter off of our parkways – and the NAHC, while disagreeing with the need to remove HOA communications, hopes that enforcement will continue to be fair and equitable to all.

Mayor A. George Pradel and the Naperville Sister Cities Commission are proud to announce a call for entries for the Young Artists Showcase competition.



The Illinois Park and Recreation Association has selected the Naperville Park District's Toadstools and Pollywogs preschool program as the winner of the 2010 Outstanding Program Award.

Toadstools and Pollywogs is one of the state's first nature-based preschools, with a mission to provide a traditional preschool curriculum incorporating outdoor play, nature exploration, and environmental practices, such as recycling and conservation. Now in its second year of operation, Toadstools and Pollywogs meets in the Wigwam building at Knoch Knolls Park, where children can play and explore acres of open space, including prairie, woodlands, and wetlands.

Over the course of the year the children learn good habits that promote sustainable living, such as recycling, bringing their own re-usable plates, cups, and spoons for snacks, and using both sides of each piece of paper when possible. These practices also carry over to the preschool families. For

example, teachers report that families often will take nature walks on the weekends, with the children leading the way. The preschool provides a magazine rack at the front door where parents and teachers can exchange magazines instead of just tossing them.

According to the Chesapeake Bay Foundation, children spend an average of 6 hours a day in front of the computer or television and only 4 minutes a day in unstructured outdoor play. Toadstools & Pollywogs Preschool gives families support in moving toward a more active lifestyle, starting while children are young.

As a member of the FORWARD (Fighting Obesity Reaching Healthy Weight Among Residents of DuPage) Coalition, the Naperville Park District seeks to offer programs such as Toadstools and Pollywogs that can provide families with positive strategies for fighting childhood obesity.

The loan extension request was a finding of the recent Library Customer Satisfaction survey. Over 50% of respondents asked for an increase. Extending rentals of DVDs and Blu Ray discs was the area mentioned most often in the survey. DVD loan periods will now be seven days rather than three. Books, magazines, audiobooks, CDs, and downloadable eAudiobooks and eBooks may now be taken out for three weeks. DVD sets with three or more discs, multimedia kits and downloadable eMusic and eVideo, will be loaned for two weeks.

That is why the Library has adopted the Public Library Association's *Every Child Ready to*

Read® program to promote the development of the six early literacy skills that prepare children under six to be ready to learn to read.

Early literacy refers to everything your child knows about reading and writing before they can actually read or write. Children start learning at birth, and the latest research has shown that the skills to help children learn to read are acquired long before their first day of school. Our goal is to help you provide a language rich, verbally stimulating environment for your child. One where everyday sounds, letters, shapes, books, songs, and rhymes will help make the connections that are the basis for learning to read. You are your child's first and most important teacher and we want to encourage you to talk, sing, play, and read with your child in a positive and fun atmosphere. Early literacy is not about memorizing, flashcards, drills, or study, and it's not teaching your child to read. It is about interacting, talking and reading with your child daily – with fun as the most important ingredient.

You will notice Library staff leading storytimes referring to these “early literacy” or pre-reading skills:

- Letter Knowledge: Learning that each letter is distinct and that each letter has its own name and unique sound.
- Phonological Awareness: Being able to hear and play with the smaller sounds in words.
- Narrative Skills: Being able to describe things and events, being able to tell stories.
- Print Motivation: Being interested in, and enjoying, books.
- Vocabulary: Knowing the names of things.
- Print Awareness: Noticing print, knowing how to handle a book and knowing how to follow the words on a page.

Children's Services staff will suggest activities during storytimes to help you discover the many ways you can reinforce pre-reading skills with your young child.

We look forward to seeing you at the Library, enjoying the books, puzzles, alphabet rugs, puppets, and educational displays and handouts near the storytime rooms. We can all make a positive difference in the future success of our community's children with *Every Child Ready to Read!*®. Coming In May – NAHC Elections

In accordance with our bylaws, the Naperville Area Homeowners Confederation will hold elections at the Confederation Annual Meeting, scheduled for Saturday, May 21, 2011 at 8:30 AM in meeting rooms B&C of the Naperville Municipal Center, 400 S. Eagle Street, Naperville, Illinois. The offices to be voted on are President of the Confederation (currently Dr. Bob Buckman); Vice President (currently Bob Fischer); and two at large Director Positions (currently held by Allen Panek and Rick Strawbridge). All incumbents are eligible to run again for their current positions.



A nominating committee will be formed at the March 19th General Meeting and will prepare a slate of recommended candidates to be announced at the April meeting. Nominations will also be accepted from the floor the day of the meeting. Any person who, at the time of the election, is a member of a homeowners association which is a Confederation member in good standing may seek and hold office on the Confederation Board of Directors; except that there shall be no

more than one Confederation Officer or a total of two Confederation Board of Directors members from any one Confederation member association.

Duties of the positions to be elected are as follows:

President – shall be the chief executive officer of the Confederation; shall preside at all meetings; shall be the chairperson of the Confederation Board of Directors; and shall be the custodian of the corporate records and seal. All records of Confederation business shall be and remain the property of the Confederation, including but not limited to electronically-stored records. The President shall also ensure (and may delegate to other Board Members the direct responsibility to see) that all newsletters, notices to member associations, and other Confederation communications, are promptly sent and distributed in a timely and appropriate manner and shall ensure that the Secretary is provided, in a timely and appropriate manner, copies or other adequate information on all such communications.

Vice President – shall assume all duties of the President in the event the office of President becomes vacant for any reason, and shall perform such other duties as assigned by the President of the Confederation Board of Directors.

At-Large Board Members – shall be chairpersons of Ad Hoc Committees of the Confederation as formed at the discretion of the BOD. They shall be eligible to assume the terms and duties of Confederation officers, if such officers resign, refuse, become ineligible, or are otherwise unavailable to fulfill their terms. At-Large Board Members shall be empowered to vote in all decisions of the BOD. If any elected Director is not able for any reason to complete a term of office, the BOD may appoint an Associate Director to serve as a Director until the next annual election and any individual so appointed shall be empowered to serve and perform their duties upon appointment.

All member associations in good standing are eligible to cast a vote in this election. To be considered in good standing, member associations are to be current in their annual dues.
