Tax Levy Update

- Property Taxes are based on the total of the annual levies submitted by the various taxing districts divided by the total assessed valuation within that taxing district. Your individual percentage is your EAV divided by the total EAV for the taxing district.
- Two factors determine your bill – amount levied and your overall piece of the pie within the representative community

Tax Levy Update

City of Naperville - Total proposed levy is flat compared to 2014, the amounts to be levied for the General Corporate and Special Purpose portions, excluding principle and interest payments represent a 7.4% increase from 2014 extension amounts. An additional \$2.0 million abatement will be filled during the first quarter of 2016 corresponding to the implementation of the Home Rule Sales tax starting January 1, 2016.

Tax Levy Update

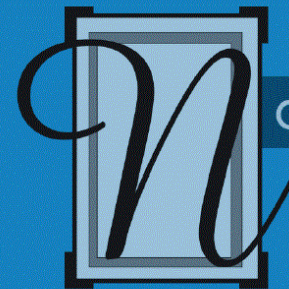
Naperville Park District (meeting on December 15th): Property tax revenue provides 49% of the total revenue of the District. The increase in the proposed levy will provide funding for District operating costs and funding for special recreation needs and required ADA improvements. On the operations side, the levy increased .8% as dictated by the December 2014 CPI percentage increase. Based on the special recreation needs included in the 2016 budget and ADA capital improvements, the Special Recreation Levy is proposed to remain constant at 4-cents of the District's Equalized Assessed Valuation (EAV) (4-cent per \$100 of EAV).

Tax Levy Update

- District 203 – 2.11% (\$816K) increase over last year. (Final vote on December 21)
- District 204 – (Public hearing held 12/7) - The total levy request for 2015 is \$256,144,324, an increase of 4.6% over 2014

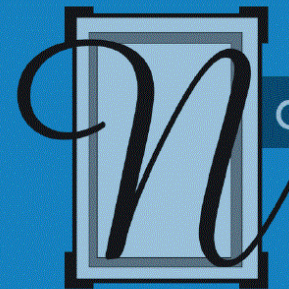

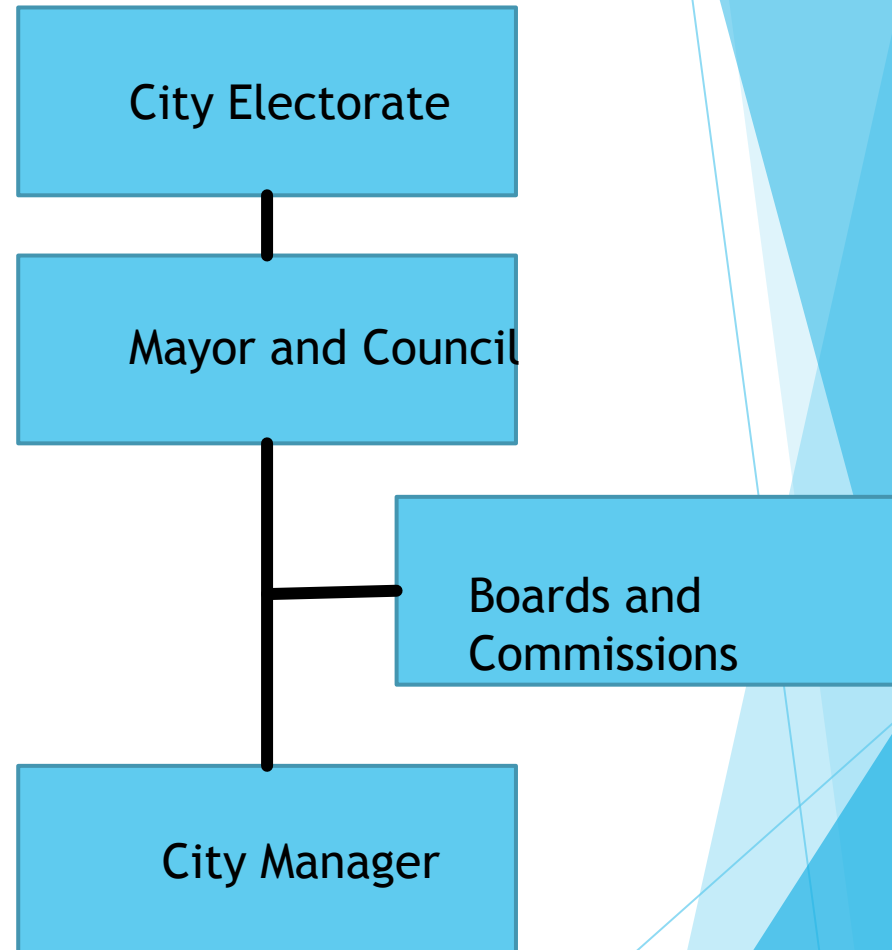

Role In City Government

- ▶ Varies among the different boards
 - ▶ Many provide advisory opinions to the City Council for consideration
- ▶ Vital to the success of our community
 - ▶ Different and valuable perspectives
 - ▶ Provide less formal forums for public involvement
 - ▶ Identify opportunities to meet community needs (e.g. Housing Expo)
- ▶ Some have statutory responsibilities
- ▶ Evolving to meet the needs of the community
 - ▶ Technology Advisory Committee
 - ▶ Senior Task Force - ADA Commission

City Council Consideration

- ▶ The Mayor and all eight City Council members served previously on a board or commission
- ▶ Actions and summaries are included in all City Council memorandums
- ▶ Instills confidence in decision making
- ▶ Significant weight given to recommendations
 - ▶ Planning and Zoning Commission
 - ▶ Public Utilities Advisory Board
 - ▶ Transportation Advisory Board
 - ▶ Advisory Cultural Commission

 - ▶ Reference

Selection Process

An opening is available on a board/commission



Is there a current pool of applicants? (Some boards have specific requirements, such as occupation, resident of certain area)



Applications are reviewed (Mayor Chirico has put additional emphasis on cultural, geographic, and gender diversity)

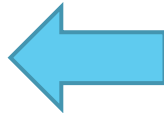


Mayor interviews potential board members

If no, advertise via press release, social media, website



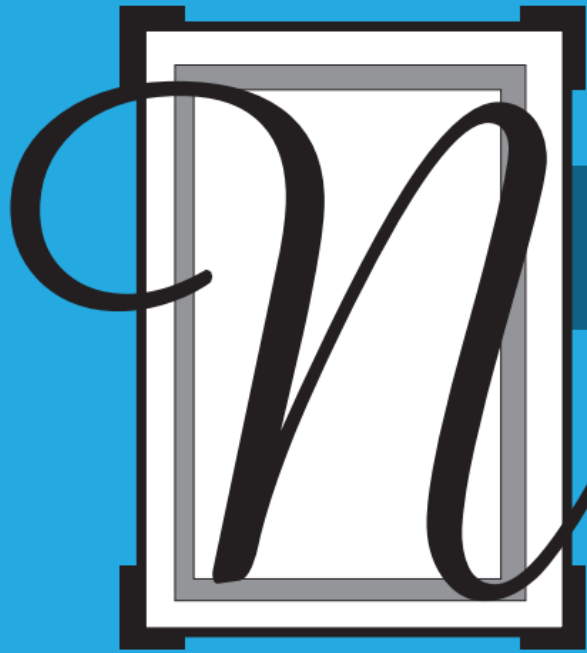
Since May 1, 2015, there have been 21 appointments and 19 reappointments by Mayor and Council

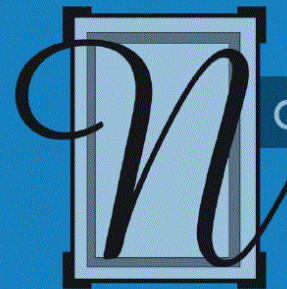

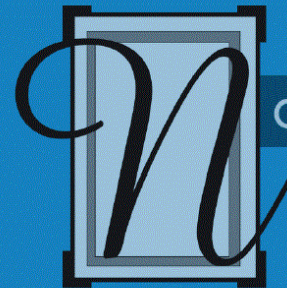
