Candidates Forums

Two important election dates are coming up. On February 27th there will be a primary election in the City of Naperville where voters will choose which two candidates among the field of Mayor George Pradel and Councilmen Mary Ellingson and Doug Krause will be on the final ballot for Mayor.

On April 17th there will be a general election where candidates for Mayor, City Council, School Boards (203, 204, and Community Colleges), and the Park District Commissioners will be elected.

The Naperville Area Homeowners Confederation will once again sponsor a series of Candidate Forums as a means to help Naperville residents make their voting selections.

At these forums, the candidates for office will be asked several questions posed by the NAHC, after which those in attendance will be encouraged to pose their own questions. All members of the public are heartily welcome to attend all of these forums, which will be held in the City Council Chambers of the Naperville Municipal Center, 400 S. Eagle Street, Naperville, Illinois.

The forums will also be televised "live" over Channels 6 (WOW) and 10 (Comcast), and rebroadcast over NCTV Channel 17.

All forums will begin at 7:30 p.m.

Kevin Dolan has agreed to be the moderator for these forums with Jason Altenbern as the deputy moderator. These forums will not be structured as a debate, but rather will have the candidates responding to questions proposed by the Confederation and the audience. The Confederation will prepare two questions that will be given to the participating candidates in advance. In addition, each candidate will be given time for an opening and closing statement.

NAHC Elections to be held in May

In accordance with our bylaws, the Naperville Area Homeowners Confederation will hold elections at the May General Meeting, scheduled for Saturday, May 19, 2007 at 8:30 AM in the Naperville Municipal Center, 400 S. Eagle Street, Naperville, Illinois.

The offices that will be voted on include President of the Confederation (currently Chuck Schlabach), Vice President (currently Dr. Bob. Buckman), and two at large Director positions currently held by Rick Strawbridge and Bob Fischer. All incumbents, with the exception of Dr. Buckman, are eligible to run again for their current positions.

Duties of the open positions are as follows:

President: - shall be the chief executive officer of the Confederation; shall preside at all meetings; shall be the Chairperson of the Confederation Board of Directors; and, shall be the custodian of the corporate records and seal. All records of Confederation business shall be and remain the property of the Confederation, including but not limited to electronically stored records. The President shall also ensure (and may delegate to other Board Members the direct responsibility to see) that all newsletters, notices to Member associations, and other Confederation communications are promptly sent in a timely and appropriate manner and shall ensure that the Secretary is provided, in a timely and appropriate manner, copies or other adequate information on all such communications.

Vice-President – shall assume all duties of the President in the event the office of the President becomes vacant for any reason, and shall perform such other duties as assigned by the President or the Confederation Board of Directors.

At-Large Board Members – shall be chairpersons of Ad Hoc Committees of the Confederation as formed at the discretion of the Confederation Board of Directors. They shall be eligible to assume the terms and duties of Confederation officers, if such officers resign, refuse, become ineligible, or are otherwise unavailable to fulfill their terms. At-Large Board Members shall be empowered to vote in all decisions of the Confederation's Board of Directors. In the event any elected Director is not able for any reason to complete a term of office, the Board of Directors may, by a vote of the majority of Board members then serving, appoint an Associate Director to serve as a Director until the next annual election and any individual so appointed shall be empowered to serve and perform their duties upon appointment. If the Board of Directors cannot appoint a replacement by a majority of the currently-serving members of the Board of Directors, then a special election shall be held, at the next regularly scheduled confederation meeting that comes after the Confederation meeting at which the election is announced.

A nominating committee will be formed at the March General Meeting to prepare a slate of recommended candidates. Home Based Business Ordinance Update

The City Council approved revised home based business ordinances at their meeting on January 16th. The ordinances that were approved were crafted by City Staff with significant input by the Homeowners Confederation and the Chamber of Commerce. We feel the ordinances as passed are fair to both home based businesses and neighbors and should serve to improve the quality of life in Naperville. The final draft of the ordinance regulating home businesses can be found on the Confederation website at www.napervillehomeowners.org under News and Info, Home Business.

Key to the ordinances was language prohibiting the home based business from conducting business operations outdoors on the subject property. By keeping business activities "inside," it was felt that the intrusion on the neighborhood by otherwise commercial ventures would be controlled. Additional language addressed off street vehicle and trailer parking and limitations on business traffic and deliveries. The partnership between the Chamber of Commerce and Homeowners Confederation, working with and through the City Staff, Plan Commission, and City Council to craft appropriate ordinance language exemplifies why Naperville is a great place to live and work.
