President's Letter from Chuck Schlabach

The Naperville Area Homeowners Confederation Board of Directors is actively planning meetings for the next nine months with topics of interest to homeowners and taxpayers throughout the Naperville area. To address the stated desire of our members to be informed of and become involved early with issues impacting their neighborhoods, each month will focus on a single topic and involve governmental units and other agencies, ranging from those with a local to a statewide focus.

Presentations will come from School Districts 203 and 204, the Naperville Park District and Public Libraries, representatives of Will and DuPage counties, and the City of Naperville. We will focus on traffic, development, community services and resources, recreation, government activities and legislation, and proposed initiatives that may impact our property tax bills. Our perspective is that of residents, property owners, and users of services. An underlying concern of every meeting will be impacts on quality of life and property values for area residents, both within and outside Naperville's municipal boundaries.

Beyond the topics included in our meetings, our Liaison Committees are actively involved in the community and bring issues to member attention through direct contact with impacted associations and through notices in our monthly newsletter and on our website.

The NAHC has a very broad constituency. We represent associations of single family homeowners, condominium and townhouse complexes, and apartment dwellers. One of our challenges is staying relevant to all of these constituencies with programs, services, and resources of value to each and all. We appreciate feedback and questions from member associations and welcome new member associations to our organization.

Beyond our meetings on the third Saturday of every month, we are also planning educational programs addressing areas of concern to officers and boards of homeowner associations. These programs, directed at the leaders of voluntary and mandatory associations alike, will provide information on governance, maintaining resident involvement, and fiduciary responsibilities. Through our website we provide links to programs scheduled by the CAI and other groups serving the needs of associations and their membership. Finally, our monthly newsletter is seen by over 500 community and HOA leaders who receive it via email or download it at www.napervillehomeowners.org.

We look forward to seeing all member associations at our next general meeting, Saturday, October 20th, at 8 AM in rooms A, B, and C of Naperville's Municipal Center. Our focus will be on development and we will review Naperville's Capital Improvement Plan, an important roadmap that impacts multiple facets of community life including traffic, infrastructure, and services delivery. We will also get updates on the proposed enhancements to the Ogden Avenue Corridor and the potential reconfiguration of the Martin Mitchell bequest. See you on the 20th!!!

NAHC Meetings: *Your Forum!!!!*

The next general membership meeting for the Naperville Area Homeowners Confederation will be held on Saturday, October 20th, in meeting rooms A, B, and C on the lower level of Naperville's Municipal Center, 400 S. Eagle Street, Naperville, Illinois.

October's joint meeting with the City Council will focus on development in and around Naperville. Working with representatives of Naperville's TED (Transportation, Engineering, and Development) team, we will look at the Capital Improvement Plan for 2008 and beyond. The CIP is an important document as it outlines expenditures for infrastructure improvements including traffic flow and public safety. Members in attendance will be able to take a look at those projects planned in their neighborhoods!

We also expect the timing to be right to get the latest updates on the proposed enhancements to the Ogden Avenue Corridor and the Martin Mitchell Estate area proposals for realignment. Whether as a shopper or as a commuter, the planned changes to the eastern end of Ogden Avenue in the City can have a wide impact for all area residents.

And, as noted in the article below, the Confederation is looking for direction from its membership on the proposed redevelopment of the Water Street area south of the City's downtown. With Council actively reviewing Water Street plans and proposals, this meeting will present an opportunity for Confederation members to voice their opinions on this major reconstruction of a portion of the city's core.

As usual the meeting will start at 8 AM with coffee, donuts, and networking. The meeting will kick off at 8:30 sharp and conclude at 10:30 following our Open Forum.

Water Street Re-Development

At its regular General membership meeting on October 20th, in rooms A, B, and C of Naperville's Municipal Center, the NAHC will ask its members to approve the report and recommendations of the NAHC Zoning & Land Use Liaison Committee relating to the proposed Water Street development project as the Public Stand of the Confederation.

The Committee identifies several problem areas with the proposal, including 60-foot-plus tall buildings bordering the Riverwalk, narrowing the traffic and pedestrian right-of-way on Water Street with narrower sidewalks than elsewhere in downtown, plus numerous traffic and congestion issues.

The Committee finds merit in many features of the project, but because the Committee believes these are out-weighted by the problems mentioned, the Committee recommends the project be rejected.

If approved by the Members, the NAHC will advise City Council of the Confederation's position, and provide Council members with copies of the Committee's report.

The NAHC Zoning and Land Use Committee report can be found on the Confederation website at www.napervillehomeowners.org. The report, as well as other information on the Water Street project, can be found by clicking on "News & Info" on the left hand navigation menu and then on "Water Street Re-Development."

The NAHC encourages area homeowners to learn more about the project. Besides our committee report, we have posted other information regarding this project, including detailed site plans, shadow studies, and the developer's traffic study under "News and Info" on the left hand navigation menu of the NAHC website at www.napervillehomeowners.com. The Board welcomes and appreciates input from our members regarding the pros and cons of the proposed redevelopment.

Yard Signs

The Confederation recently received a question about the display of informational/advocacy signage in residential areas. The information below governs the placement of this type of signage within the Naperville city limits. Please contact City Code Enforcement at (630)420-6070 with any further questions.



Non-commercial signs are not directed at promoting commercial activity and include political campaign and advocacy signs. These signs, which are not subject to time limitations, are covered by the regulations found in Section 5-4-5 of the City's Municipal Code:

Such signs shall meet the following regulations:

1. A single support structure shall not contain any sign(s) in excess of eight (8) square feet in total area. The area shall be determined by drawing an imaginary square or rectangle envelope so as to completely enclose the copy surface of the sign(s) or graphic, including the support structure and any attention getting borders.
2. A single sign or stacked signs, including support structures, shall not exceed five feet (5') in height.
3. Noncommercial signs related to a scheduled event, such as an election, may only be posted during the ninety (90) day period preceding the event, and must be removed within seven (7) days following the event.
4. Noncommercial signs shall not be posted in a manner that creates a danger to the public, either as a result of dangerous construction, sight obstruction or any other cause. Noncommercial signs shall not be permitted within twenty feet (20') of the point formed by the intersection of the curb lines of two (2) or more streets, nor within ten feet (10') of the paved portion of any street or back of curb where no sidewalk is present.
5. No permit shall be required for a noncommercial sign.

In addition to City requirements, mandatory homeowners associations may have more restrictive rules with respect to their members displaying signage. Other than the boundaries of good taste, there are generally no limitations on the expression of freedom of speech as protected by the Constitution.

Naperville Development Update

On September 19, 2007 the monthly meeting between Naperville TED Staff and the NAHC Liaison Committee for Zoning and Land Use occurred. Confederation Associate Director Patricia Meyer and Park Addition HOA President Thom Higgins represented the NAHC and Greg Jones represented the City.

Staff provided the following updates:

- Winding Creek Park (Modaff and Bailey) will be annexed to the Park District
- Chase Bank set to go in at Rt 59 and Brookdale
- Mandalay Club (248th and 103rd) in final plat for approx 20 single family residences
- Hidden Creek (?) (248th and 103rd) in preliminary plat for 18-20 single family residences
- Lizzardo Estates (77th and Wehrli) in final plat (before Council 10/2/07)
- Jewel (95th and Rt 59) expanding for drive-thru pharmacy
- Flat Top Grill will be going into the old Washington Square location (site will be remodeled)
- Houlihan's will be going into Naperville Crossings
- AmCore Bank will be going into an outlot at Rt 59 and Audrey
- Staples will be going into old Rizza location on Ogden
- Treehouse at the Ravines (Diehl and Warrenville) is before Council on 10/2/07 for 400+ room hotel (108ft tall) and 2 condo towers development. This is controversial as the zoning is not residential and developer wants changed to OCI instead of ORI (it's the condo portion) and that the height



exceeds what Staff would like (admittedly – this is the area which height is acceptable but this project is too much per Staff)

- Red Light Photo Enforcement was approved 9/19/07 by Council – intersections that will be used are unknown at this time.
- Water Street is before Council 10/2/07 for approval. Developer did lower TU bldg to 40ft. but no other changes to plans at this time. Per Staff there is an outstanding issue of the setback for the TU bldg. Per Staff: developer wants prelim approval from Council but will wait after that until TIF decided. Discussion occurred as to FAR of the project and that the governing height is not 45ft as previously believed – it is FAR. NAHC requested a breakdown of the FAR determinations to better understand the 1.92 ratio quoted by developer. Staff confirmed that whether 2-5 stories, the Riverwalk and the River will be in shadows at various points per the time of year and that the impact is minimal.

Pace Bus is slated to cut the majority of its service in Naperville on November 4, 2007, unless the transit agency receives additional funding from the RTA. This loss of service will severely impact all Naperville commuters including over 700 Pace riders who will be forced to compete for daily parking spaces at both Metra stations, placing even more burden

“If enacted as proposed, these cuts will impact all commuters in Naperville, including Pace and Metra passengers, and even those that drive to work daily,” said transportation and planning operations manager Carmen Carruthers. “Without bus transportation to and from the Metra stations, the competition for parking spaces and traffic at these locations will increase significantly.”

The proposed cuts include the elimination of all Metra feeder routes in Naperville, as well as Pace Route 787/788 that provides limited midday service to the Ogden Mall area and schools in the southeastern portion of Naperville. In addition, fares will increase for Pace local routes (Pace Route 530 intra-Naperville trips) and vanpools. Pace Routes 714, 530 and 535 will be all that will remain in the Naperville area.

Legislative Update – New Standards for Community Association

Public Act 95-0318 is the first step in a legislative process to enhance professionalism of community association managers. Introduced as House Bill 1071, the bill protects association boards and owners whose managers administer association funds and maintain association property by creating a new Section 18.7 of the Illinois Condominium Property Act that requires community association managers to maintain standards of professionalism and financial responsibility. The bill passed the House of Representatives on May 1, 2007, was approved by the Senate on May 22, 2007, was signed into law on August 21, 2007 by Governor Rod Blagojevich (D).

This new law, effective January 1, 2008, represents a legislative compromise to initial efforts to license property managers and is the first step of a joint effort between the CAI and the Illinois Association of Realtors to license community association managers. Section 18.7 sets standards for community association managers, and applies to managers of condominiums, cooperatives, townhomes or homeowner associations. The new law has the following provisions for managers:

- Managers are individuals who administer for compensation financial, administrative, maintenance, or other duties called for in a management contract, including individuals who are direct employees of a community association (but does not include support staff such as bookkeepers, secretaries, etc.).
- Managers must be 21 and a citizen or legal permanent resident of the United States.
- Managers shall not have been convicted of forgery, embezzlement, obtaining money under false pretensions, etc.
- Managers shall have a working knowledge of the fundamentals of community association management.
- Managers must cooperate with any law enforcement agency in the investigation of a management complaint and produce any materials in their possession or control in management transition.
- Managers will not have sole and exclusive access to and disburse association funds unless there is a fidelity bond in place. The amount of the bond must not be less than all monies of that association. The bond covers the managers and all partners, officers and employees of the management firm.
- Managers shall maintain separate, segregated accounts for each community association.

City Looks to Public for Input on Soundwalls

Demonstration Walls Constructed at 75th and Washington Street Intersection

The City of Naperville is seeking public input on demonstration sound walls located at the northwest corner of 75th Street and Washington Street via an online survey. The survey, available at www.naperville.il.us/soundwall.aspx, will be open through February 2008 to allow the public to view the walls during different seasons.



Demonstration walls from five different manufacturers have been constructed to provide the public with an opportunity to comment on which features of the walls they find appealing. Nearly 1.5 miles of sound wall will be constructed at this location in 2008 to help reduce the impact of traffic noise on the Maplebrook neighborhoods.


Each of the demonstration walls can be manufactured with similar textures and colors to meet the requirements of the stakeholders; however they all have slightly different characteristics. It is these characteristics that the city would like to evaluate with input from the community.

The purpose of this survey is **not** for the public to pick a favorite wall. The city wants to know what aspects of these walls appeal to the public and which do not. This information will be used to help determine which wall manufacturers will be invited to bid on the final installation and what characteristics will be included in the end product.

The City of Naperville will be evaluating appearance, quality of materials, ease of installation, fading and weathering, and maintenance requirements. Homeowner's Garden Tips for October

From The Growing Place nursery & flower farm, inc.

As crisp evenings arrive and fall color surrounds us, the garden needs to get ready for its rest. Bring tropical plants indoors when night temperatures drop below 50 degrees. Cover tender plants when frost is predicted.

Empty containers and bring them indoors. Pot tender herbs and set in a sunny window. After first frost, lift dahlias, gladiolus, cannas. Discard tops and store in dry peat moss or vermiculite. Then cut back and clean up garden, rake leaves and compost debris or rototill into soil.

Plant spring-flowering bulbs. Pot bulbs for indoor forcing.

After leaves fall, transplant deciduous trees and shrubs. Water plants deeply, especially evergreens, before the ground freezes. Apply tree wraps to newly planted trees. Keep mulch away from tree base.

Budget issues may impact hazardous waste recycling




DuPage County is planning to cut \$100,000 of funding for the Regional Household Waste Facility located at Naperville Fire Station 4. This means environmentally conscious residents, businesses and local governments will be forced to drive to Rockford or Chicago to properly dispose of hazardous waste. Another possibility is that the waste currently dropped off at the regional site could end up in landfills starting December 1.

“The amount of household hazardous waste dropped off at the facility last year just in oil and anti-freeze alone amounted to over 17,000 gallons of liquid that could end up in our rivers, lakes or landfills if the Household Hazardous Waste (HHW) facility were not in operation,” said Department of Public Works Director Dave Van Vooren. “In addition to liquid hazardous waste, the facility received 394,100 pounds of dry good waste last year including batteries, propane tanks and prescription medicine.”

The City of Naperville serves as host to the Regional Permanent Household Hazardous Waste Collection Facility. This facility is managed by the city through intergovernmental agreements with the State of Illinois Environmental Protection Agency (IEPA), and four funding governments, the City of Aurora, Will County, DuPage County and Kane County. It is one of only three in the State of Illinois; the others are located in Rockford and Chicago.

Since the inception of the regional program in 1992, the site has serviced over 157,822 vehicles and provided safe disposal for over seven million pounds of hazardous household products. The IEPA is responsible for disposal costs and the participating counties and cities pay a portion of the staffing and operational costs. DuPage County funding provides 60 percent of the HHW facility operating budget. The remainder comes from Will and Kane Counties and the Cities of Naperville and Aurora. In addition, the City of Naperville provides a secure location for the collection and storage of materials until the IEPA takes over the chain of custody and control. **DuPage County’s financial support of the HHW facility is slated to end on November 30.**

“We need DuPage County to continue its funding in order to keep this facility open,” said Naperville City Manager Peter Burchard. I am very concerned about the environmental impact if residents do not have any reasonable options for disposing of hazardous waste.”
