## **NAHC Legislative Update**



The Board of the Naperville Area Homeowners Confederation has agreed to work with the City of Naperville in support of several of the City's 2008 Legislative Initiatives.

These include:

- City Priority One – Capital Bill
- City Priority Three – Opposition to Canadian National Purchase of EJ&E Railroad
- Tax Relief for Seniors and the Disabled

Over the upcoming months we will be working with the City and our membership to determine the best ways for the Confederation to add its voice to that of the City in support of (or in the case of the railroad, opposition to) these matters which all have direct impacts on our community and quality of life. Support of these items does not indicate our opposition to other areas on the City Agenda, but rather is meant as an indication on where we plan to focus our support.

In addition, the NAHC Board has contacted State Representative Joe Dunn and expressed our opposition to Illinois General Assembly, HB 5189, introduced by Rep. Sandra Phibos of Glen Ellyn that limits the ability of Condominium and Homeowners Associations to regulate leasing of units within their respective associations. While this bill was amended in committee to make it applicable only to new associations formed after the effective date of the legislation, we are still of the opinion that this proposed legislation infringes on the ability of associations to govern themselves by providing arbitrary numerical guidelines. Representative Dunn agreed with our concerns and has opposed the bill but it remains alive in committee. Other associations are welcome to add their voice in opposition.

With the downturn in the Real Estate market it is understandable why there is both a need for and interest in leasing of units, but it may also be questioned as to why legislation is required to force associations to allow leasing, the desirability of a numerical minimum, and what further impacts this legislation may have on the other powers and abilities of associations to manage their environment. The bill is also being supported by advocates of affordable housing.

Another piece of legislation currently making its way through Springfield is SB 2128 which amends the Condominium Property Act and requires licensing of managers of community associations. This proposal creates the Community Association Manager Regulatory Commission, whose members are appointed by the Governor, to administer the licensing. While the NAHC has not taken a position on this proposal, we understand that at least some of the language is supported by the CAI. If passed in its present form it will affect all community associations whether or not they are managed by professional managers.

Locally the Confederation has commented on the proposed changes to the Downtown Noise Ordinance, proposed changes to the Sign Code, and revisions to the PUD framework. ## **Zoning and Land Use Update**

The monthly meeting between the NAHC and City TED Staff was held on March 19, 2008. Present were Greg Jones and Suzanne Thorsen of the transportation, Engineering, and Development Team and Toby Hayer and Patricia Meyer representing the Confederation.

### **Highlights from City Council Meeting on 3/18/08:**

- Council discussed the property requirements for vacant lots. Essentially regulating the maintenance and aesthetics of parcels of property which has not yet been developed or torn-down. Items such as grading, black dirt, debris, seeding were mentioned. The matter was continued to 4/1/08
- Council approved language to the Building Code which recognizes new products (i.e. insulation)
- A 5 year extension was granted for the Park-n-Ride at Community Christian Church (Rickert & Ogden)



### **New Items:**

- Bill Jacobs (car dealership) has submitted plans for a car dealership at Aurora & Fort Hill
- Water Street Development Project Phase 1 (south of Water) is in Final PUD and final engineering.
- CIP for 75<sup>th</sup> & Washington is on track and should commence this summer
- An architectural survey was recently sent to homeowners in the historic district. The survey seeks to confirm the historical status/information/description of the homes. Meetings are scheduled for 3/24/08 and 4/14/08

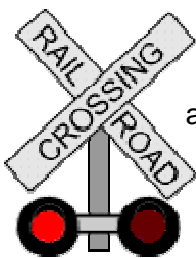
## Other Items:

- North Downtown Study/5<sup>th</sup> Avenue Study was discussed at the 3/18/08 Council meeting. Residents have suggested consideration to join the 2 studies. Options were briefly discussed however Council “tabled” the matter to 4/1/08
- 75<sup>th</sup> Corridor Study – public meeting set for 4/9/08 at which time draft objectives and actions will be presented.
- Caroline Martin Mitchell – public meeting recently occurred. Staff is preparing the report
- Ogden Avenue – grant money recently received for improvements. Staff is considering options.
- 5<sup>th</sup> Avenue Study – selection process for residential consultant is nearly completed (by week’s end). The transportation consultant has not been selected. Study remains on track with timeline
- Downtown Plan – scope of study is being finalized. Some factors being considered are height and use (composition of). As more information becomes available NAHC will be notified.
- Central Park Study – going well and on track. Currently in stage of Request for Proposals.
- Planning Team’s work program will be on Council’s agenda on 4/1/08
- Main Street Promenade is scheduled to be on PC’s agenda 4/2/08. This is an addition/expansion to the PUD development.
- One Naperville Plaza is also scheduled to be on PC’s 4/2/08 agenda (this is a continuance date) however it is not certain whether it will proceed at that time

## Discussion Items

- NAHC-LC reports were provided to Staff: 75<sup>th</sup> Corridor Study Progress Report and Planned Unit Development Text Amendment report
- WHOA contact name provided to Staff for the Downtown Studies
- Provided name of NAHC representative for the Sign Ordinance Update (Bob Fischer)
- PUD Text Amendment revisions were briefly discussed. Appreciation of incorporating NAHC-LC suggestions was expressed to Staff. Questions in regards to increasing Major vs. Minor Change threshold to 20%, Uses in regards to the Design Standards and underlying requirements remain an item. Staff was informed of intent to provide copy of the Committee Report to PC for their review. Staff offered to make copies and make available to all PC prior to meeting that evening.

## Help Keep Naperville on the Right Side of the Tracks



The Surface Transportation board is awaiting an environmental study on the impacts of the proposed acquisition of the EJ&E Railroad right of way and tracks by the Canadian National Railroad (CN). US Senator Dick Durbin has met with the CN in an attempt to gain concessions and assurances related to this purchase, but, according to news reports, he was rebuffed with no new concessions or promises. The EJ&E was also discussed extensively at the NAHC Legislative Forum in March with all legislators in attendance, from the Federal through State, County, and municipal level, expressing their opposition to the planned deal as presently crafted

It is critical during the study period to keep our legislators apprised of our concerns regarding this proposed purchase and drastic change in use. As mentioned in last month’s newsletter, the Confederation’s concerns center on three key topics:

- The traffic delays and safety concerns from a tripling of the train traffic across the multiple grade level crossings in our area
- The noise and potential impact on property values of increased rail traffic
- The potential loss of the ability to construct the proposed Star Line Commuter Rail system, removing the economic benefits and congestion relief available from this suburb-to-suburb transit system

By contacting elected officials the Confederation hopes that a brighter light will be shone on this proposed acquisition and that efforts will be made to address area residents' needs and requirements. The Confederation has organized a letter writing campaign amongst its members so that they can directly contact their elected representatives. ## **Ready for Severe Weather?**

Besides birds and flowers, Spring also can mean storms. Severe weather is a reality in the Midwest and every homeowner should be prepared.

The Illinois Management Emergency and the National Weather Service offer the following tips to help people stay safe during a weather-related emergency:

- Never attempt to drive over a flooded roadway. The speed and depth of the water is not always obvious and portions of the road under the water may have been washed out.
- Never let children play in or near floodwaters, flooded creeks or flood retention ponds.
- Before bad weather occurs, determine the best location in your home and office to seek shelter. A basement or cellar will usually provide the best protection. If not available, identify an interior room or hallway with no windows on the lowest level.
- When a tornado warning has been issued, go at once to your predetermined shelter. In a basement, go under the stairs, under a heavy piece of furniture or a workbench. Stay there until danger has passed.
- Avoid using the telephone or other electrical appliances and delay baths or showers until the storm passes.
- If outdoors, seek shelter immediately. If you can hear thunder, you are probably close enough to the storm to be struck by lightning.



Warning sirens are tested on the first Tuesday of each month at 10 a.m. If the steady tone is heard at any other time, it is a signal that an emergency is occurring in the community. The weather siren is

used to alert the public that a tornado has been sighted and is approaching the community. When the steady tone is heard during severe weather, it is imperative to find shelter immediately. Residents should tune in to local cable TV, 89.1 FM or 1610 AM radio for information on the emergency.

## Keeping Tabs on Technology

Growing up, most parents today didn't have cell phones, text messaging, or e-mail. But lots of us did have our own phone lines, and made calls to formal or informal hotlines for information on everything from movie times to the location of the best weekend party to crisis counseling. Our own parents had their "new" technologies, too. And none of it was good or bad; it was simply different from that of previous generations.

It's up to us as parents now to figure out how to help our kids navigate their world by being knowledgeable, involved, compassionate, and curious about how they socialize, recreate, and get information through the latest technology.

**Here are some examples of what we mean. Try it...**

**For parents with children ages birth to 5**

- Pay attention to the messages you model—stay off the cell phone, personal digital assistant (PDA), and other electronic devices when you're driving or engaged in other activities that deserve your full attention.
- When you're spending time with your kids, turn off the devices. That's what voice mail is for! Your kids need, want, and benefit from your full attention.

**For parents with children ages 6 - 9**

- Make sure your kids know what your limits are for cell phone, computer, and other device usage. Many, for example, know (or can figure out) how to access the Internet to play games online or on cell phones and PDAs.
- Don't let your kids use the Internet unattended. It's easier and more practical to monitor their usage if you have the family computer set up in a common space in your home. You can "watch from afar" or just regularly glance over to see what they're up to.
- Online social networking communities such as MySpace and Facebook are very popular, even with elementary-age kids. If your kids use these sites, know whom they allow access to on their pages and make sure they know why you've set up limits on this access.


**For parents with children ages 10 - 15**

- Let your kids know that you will regularly check their e-mail, phone, and text messaging content on both incoming and outgoing lists, and that they should limit those lists to friends and family members, not people they meet online. If you see names you don't recognize, find out who they are and how your child knows them.
- Have rules about when and where your children and you will use handheld communication devices. Suggestions include not using them at mealtimes, when visiting family or friends, when driving or operating other machinery, or when in the middle of another conversation.
- Know the school rules for cell phones in class, and consider limiting their use to before and after school only.

**For parents with children ages 16 - 18**

- Understand that regardless of the way you use technology, it's part of how young people today build their social networks and their community. Be sure that your teens understand the degree of public and private access that others have to their communications. Talk with them about what's inappropriate to share publicly, and why.
- Keep computers out of teens' bedrooms and in central family areas of your home.
- Let your teen know that some employers and colleges search the Internet for information related to applicants who apply to their institutions. Discuss the kinds of information that may compromise their chances of acceptance.
- Find out what technologies are being used in your teen's school. Do teachers keep blogs? Are student groups organized on MySpace or Facebook? Do teachers use digital whiteboards? If so, check these out periodically.

## Planned Unit Developments

Patricia Meyer, Associate Director and Chair of the Confederation Zoning and Land Use Liaison Sub-Committee appeared before Plan Commission on March 19<sup>th</sup> to testify at the Public Hearing on changes to the Planned Unit Development (PUD) ordinance. As PUD's become a bigger portion of development discussions, the NAHC liaison committees will work directly with neighboring homeowners work to include neighborhood input into these discussions and our newsletters will include listings of developments currently under discussion. PUD is the least understood “Conditional Use” of the homeowner’s zoning and many are unaware of the possibilities associated with PUD’s. Awareness of and a basic general understanding of PUD may prove beneficial to a homeowner.

As Naperville approaches build-out, future developments/re-developments will consist of “in-fill” properties. These areas (which, for whatever reasons were not developed in a manner similar to the surrounding properties or at a similar time) may request processing as PUD. Over the past several decades PUD’s have been utilized in the development of residential neighborhoods, commercial shopping centers, and more recently as mixed-use developments.

All zoning categories (with the exception of Transitional Use) provide for PUD as a “Permitted Conditional Use” which means that in order to develop/redevelop property, the applicant must follow the formal process for approval which includes public notice and a public hearing before Plan Commission. Ultimately it must be approved by the City Council.

PUD is applied for when the proposed development project would not be in strict accordance with underlying zoning (i.e. numerous Variances would be required). PUD allows the applicant to plan a project under “flexible” (negotiable) parameters that might not otherwise be allowed/approved.

PUD, because of this “flexibility” and with an ultimate goal for developments which are “innovative, imaginative, and (have) creative architectural design” thus encouraging a “higher level of design and amenity”, provides/acts as a tool or method to acquire approval in a more efficient manner.

PUD has its own category of zoning within Naperville’s Municipal Code. However, currently there are no areas/sections which list PUD as a Future Land Use zoning designation (FLU). PUD’s currently are requested/processed as a “Conditional Use”. This PUD category of zoning has its own “Standards and Criteria”. Unlike other zoning categories, these standards and criteria are usually more subjective (open to interpretation). Master Plans, Area Plans, Sector Plans, Vision Statements, Studies, and Guidelines would be utilized as the benchmarks by Staff, Plan Commission, and City Council. PUD’s are often regulated by their own development standards and criteria as well as the regulations of the underlying zoning district in which they are located.

### **Park District Garden Plots set to start 2008 season**

#### ***Organic plots and free gardening classes also available to patrons***

The 2008 gardening season is set to begin on Sunday, **Apr. 13** and will run through Sunday, **Oct. 12**. The cost is \$26/residents and \$39/nonresidents; seniors are offered special pricing at a cost of \$21/residents and \$31/nonresidents. Gardeners may register in-person or call the Park District's Administrative Office at 320 W. Jackson Avenue, 630-848-5000, or the South Maintenance Facility at 3415 Book Road, 630-864-3100.

Additionally, the Park District is offering free gardening workshops for new and returning gardeners. These courses, taught by certified Master Gardener Ron Ory, offer valuable tips and tricks in planting selections. ## **Confederation Elections**

At the Confederation's annual meeting on May 17<sup>th</sup>, in accordance with our Bylaws we will elect a portion of the Confederation Board of Directors. Up for election are the positions of Secretary, Treasurer, and two at-large Directors. Incumbents Kathy Benson (Secretary) and Directors Mike Reilly and Marcia Straub are eligible for re-election and have asked to be considered. Treasurer Marilyn Briscoe has chosen not to be considered. Any person who, at the time of the election, is a member of a homeowners association which is a Confederation member in good standing may seek and hold office on the Confederation Board of Directors; except that there shall be no more than one Confederation Officer or a total of two Confederation Board of Directors members from any one Confederation member association.



A proposed slate will be chosen by a nominating committee. If you are interested, please contact Confederation Director Bob Fischer or Associate Director Tom Harris who make up this committee. Individuals may also be nominated from the floor at the annual meeting. The roles and responsibilities of the offices to be elected are as follows:

**Secretary:** Shall keep the current minutes of all Confederation Board of Directors meetings; present a written report of the Confederation's previous year's activities at the Annual meeting; and be responsible for all correspondence relating to the business of the Confederation. The confederation Board of Directors shall approve all material correspondence of the Confederation and the Confederation Board of Directors. The Secretary shall also keep current a list of Member associations and persons to contact, and maintain duplicate copies of the corporate records.

**Treasurer:** Shall collect and receive all monies and assessments and deposit them to the credit of the Confederation in a bank approved by the Confederation Board of Directors; render a statement of accounts to the Confederation Board of Directors and to the Confederation membership at regular meetings; issue receipts for assessments upon request; challenge the right to vote of any Confederation member not in good standing at the time of any vote by reason of being in arrears in its payments of assessments; present a financial report in writing at the Annual meeting; and keep a list of all Confederation members currently in good standing. The Treasurer shall be responsible for preparing the annual budget to be approved by the members at the November meeting of each year. The Treasurer shall disburse funds that are included in the budget line items upon presentation of adequate documentation for such items.

**At-Large Board Members:** Four persons shall be elected At Large members of the Board of Directors. They shall be eligible to assume the terms and duties of Confederation officers, if such officers resign, refuse, become ineligible, or are otherwise not able to fulfill their terms. At-Large Board Members: shall be empowered to vote in all decisions of the Confederation's Board.

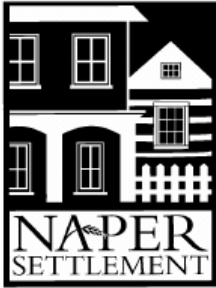
